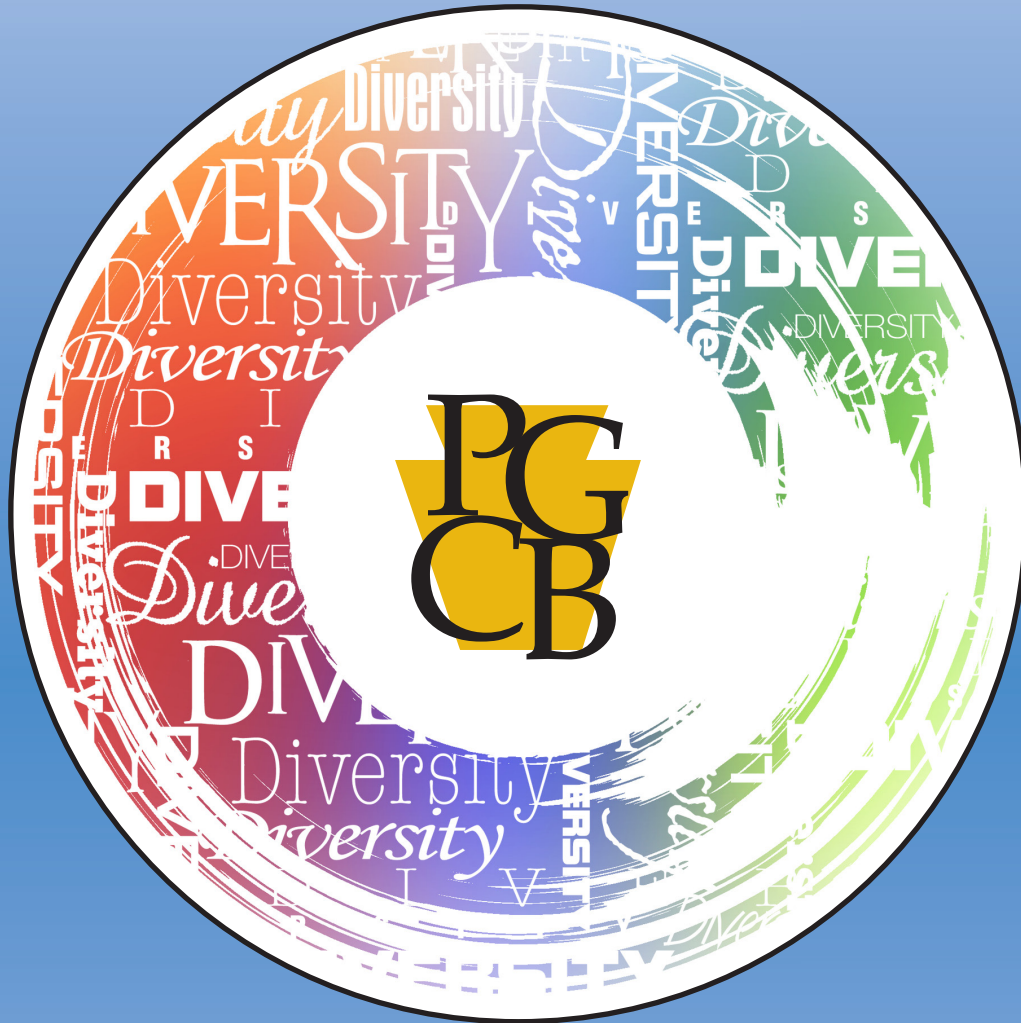

The Pennsylvania Gaming Control Board (“PGCB”) is pleased to present its sixteenth annual Diversity Report. Pursuant to §1212 of the Pennsylvania Race Horse Development and Gaming Act (“Act”), the PGCB is charged with promoting and ensuring diversity, equity, and inclusion in all aspects of legalized gaming. The PGCB developed rules and regulations, 58 Pa. Code §481a, to achieve its objectives. The diversity regulations established policies and procedures for promoting and ensuring that the regulated entities support participation and equity in all aspects of their operations in the Commonwealth.

This report provides information regarding the PGCB’s ongoing efforts in monitoring the activities of Pennsylvania’s licensed gaming facilities (“casinos”) to ensure the Commonwealth’s goals of enhanced representation of diverse groups in the gaming industry and the creation of quality living wage jobs for its residents. Sections 13A04, 1325, and 1510 of the Act require that casinos maintain local preferences in their hiring practices. As Pennsylvania’s gaming industry has evolved, diversity, equity, and inclusion have remained at the forefront of the PGCB’s mission. Notwithstanding changes to the Act, casino ownership, casino executive management, or within the PGCB, diversity, equity, and inclusion has been and continues to be an outstanding achievement of the entire industry.

On average, Pennsylvania’s casinos offer competitive salaries, benefits, and training opportunities to attract exceptional talent. Post pandemic, the casinos have developed and instituted strategies for greater resilience, retention, capability, flexibility, and productivity of employees. Despite the industry’s best efforts, a highly competitive labor market, shifts in employee expectations, and other economic disruptions continue to have a major impact on the overall employee total. On June 30, 2023, the licensed casinos/resorts employed a total of 15,461 individuals. Residents of the Commonwealth consisted of 90% of the casinos’ workforce. Approximately 42% of the employees were female while 41% of those employed at the casinos were racial minorities. Executive/Management/Professional Staff at the casinos were comprised of 2,519 individuals. Of this total, 36% were female and 27% were racial minorities.

The Commonwealth’s casinos are committed to prioritizing the professional development of workers through mentorship programs, participation in industry events and seminars, training programs, tuition reimbursement for continuing education, delegation of responsibilities in order to provide hands on experience, recognition awards, succession planning, and more. These training and retention efforts have resulted in notable internal advancements and promotions. Additionally, the casinos remain committed to achieving the Commonwealth’s goal regarding table games employment. Pennsylvania residents currently make up 84% of table games employees.

As interest rate hikes, inflationary pressures, price surges, and other economic conditions manifest, the casinos’ procurement professionals continue to design and institute new practices and technologies to support supply chain performance and vendor relationships. The sustainability strategies established between casinos and service providers during the pandemic that resulted in the formation of specialized purchasing remedies and cost solutions to ensure viability, agility, and marketability remain in effect. Additionally, the casinos continue to support organizations that promote supplier diversity and economic empowerment, such as the Minority Supplier Development Council, the Women’s Business Enterprise Center East, the Pennsylvania Department of Community & Economic Development, the Pennsylvania Department of General Services’ Bureau of Diversity, Inclusion & Small Business Opportunities, and regional Chambers of Commerce. 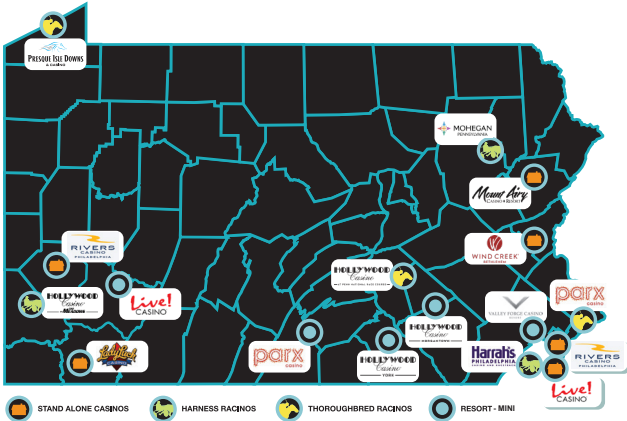
Community outreach, sponsorships, and donations to charitable causes continue to be a priority for the casinos. As in previous years, casino employees routinely volunteer thousands of hours to various organizations, fund raisers, neighborhood revitalization efforts, and educational pursuits throughout the Commonwealth. Since 2006, the casinos have distributed approximately \$187 million towards social responsibility causes and philanthropic activities.

The PGCB is committed to monitoring the activities of the Commonwealth’s licensed casinos in promoting diversity and ensuring compliance with the Act.

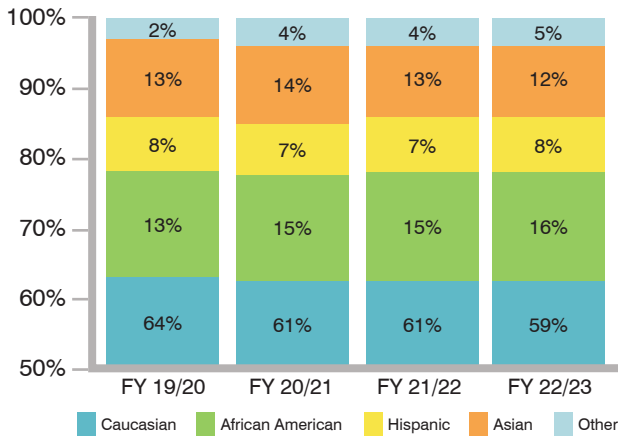


In addition to requirements in both the Gaming Act and the Board’s regulatory policies and procedures, the PGCB requires each Licensee to execute a “Statement of Conditions” in which the Licensee agrees to submit an updated version of its diversity and hiring plans on an annual basis.

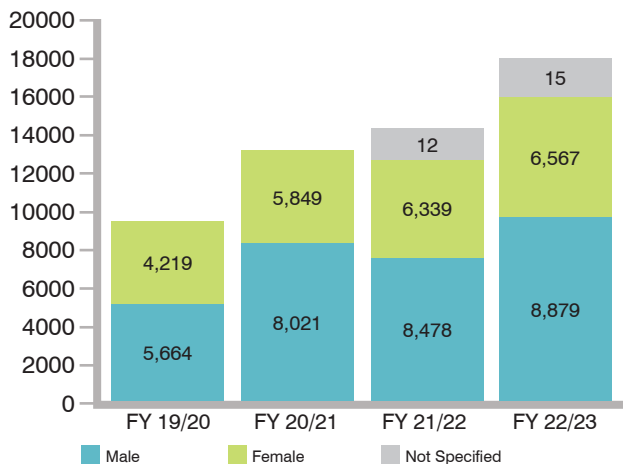

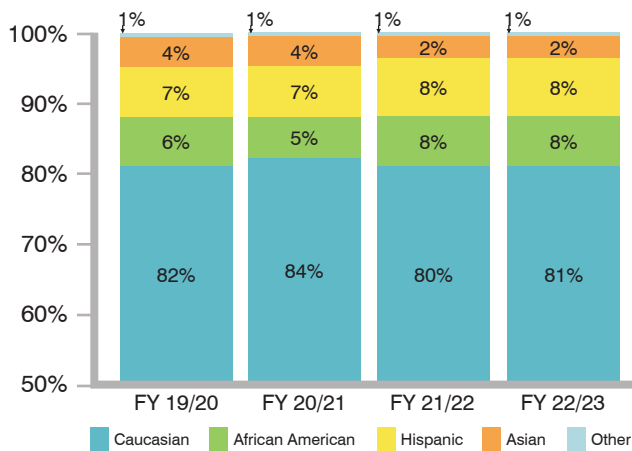
Mohegan Pennsylvania opened on November 14, 2006 in Luzerne County, Plains Township and is a harness racetrack.

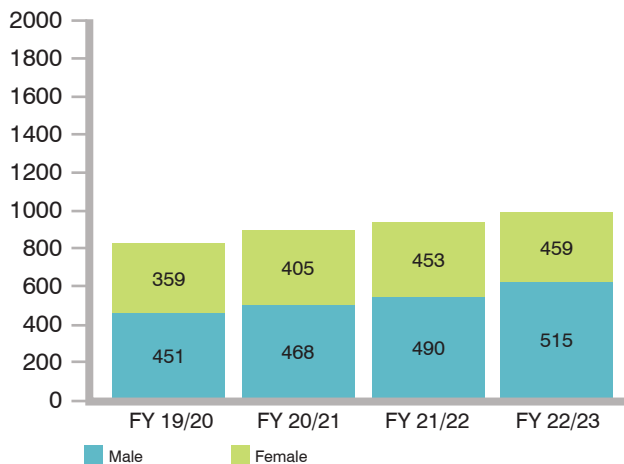

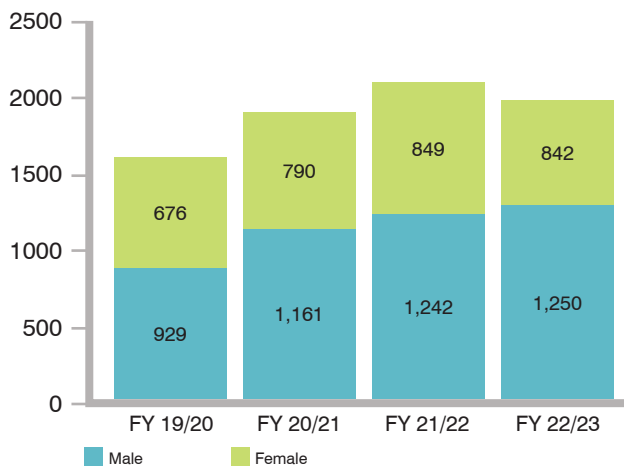

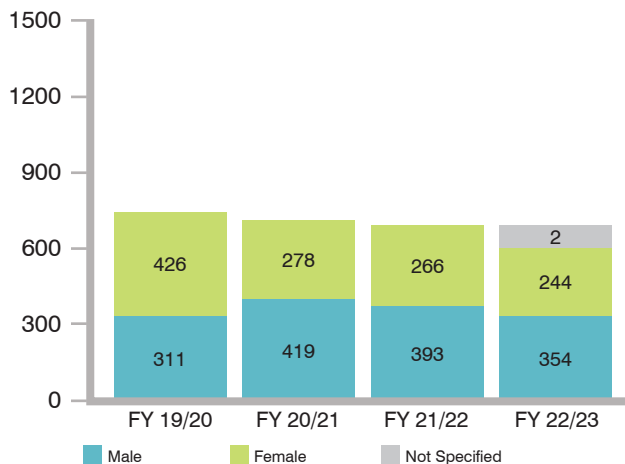

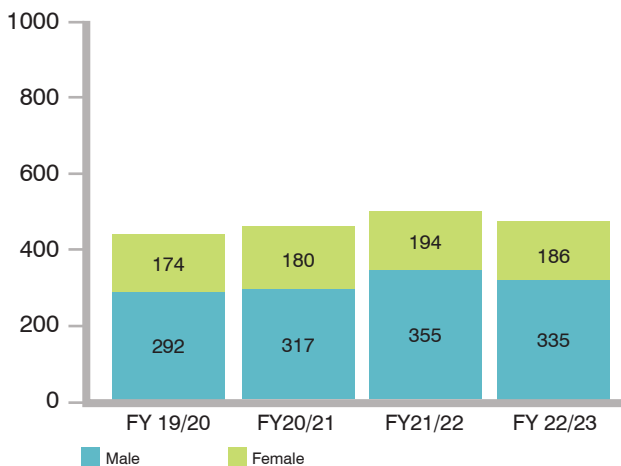

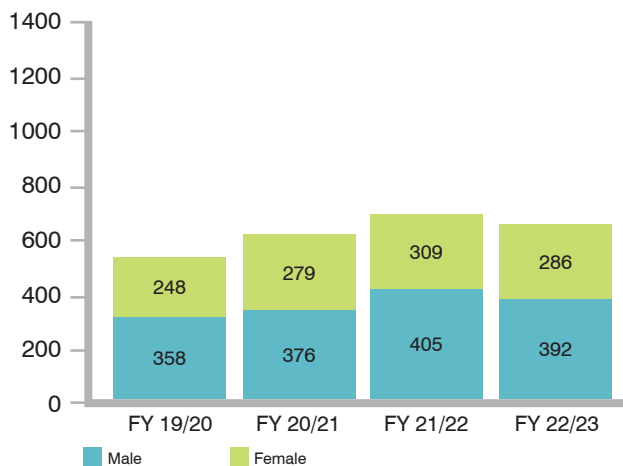

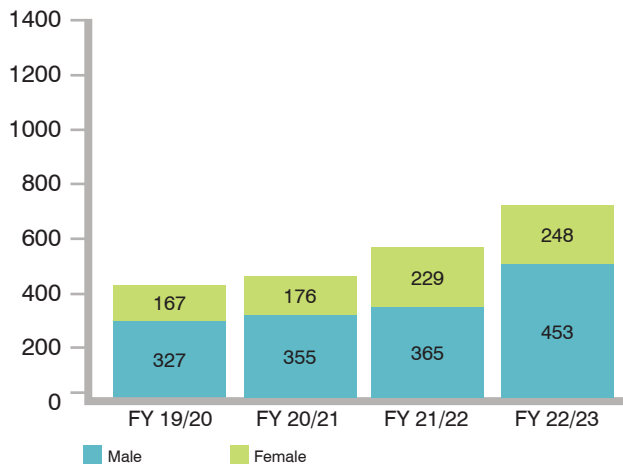

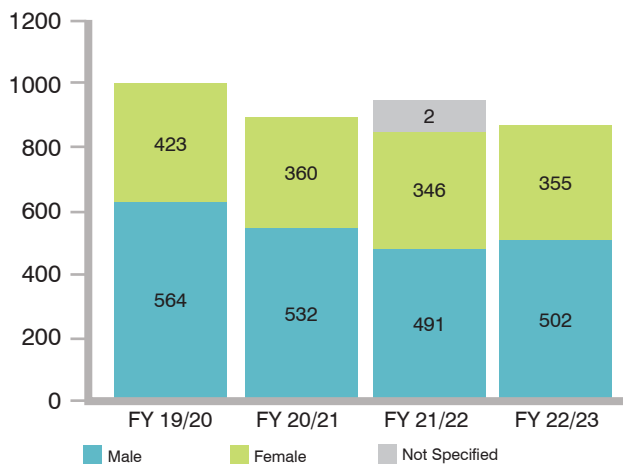

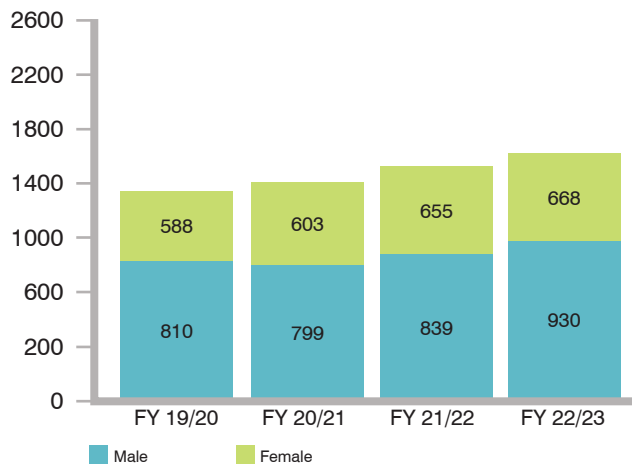

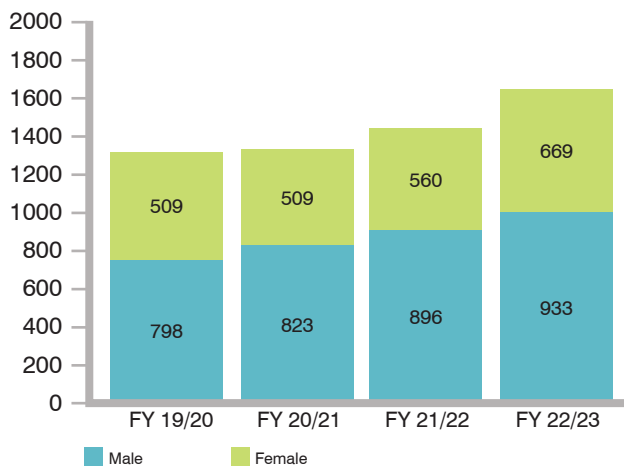

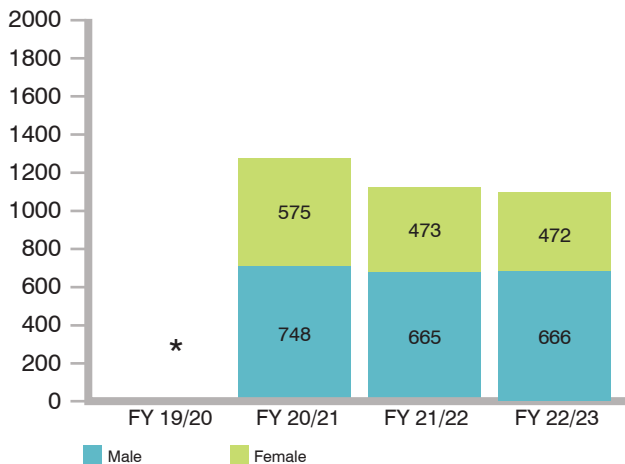

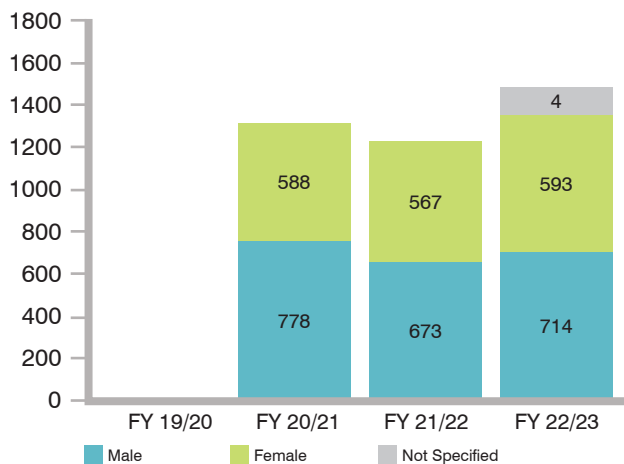

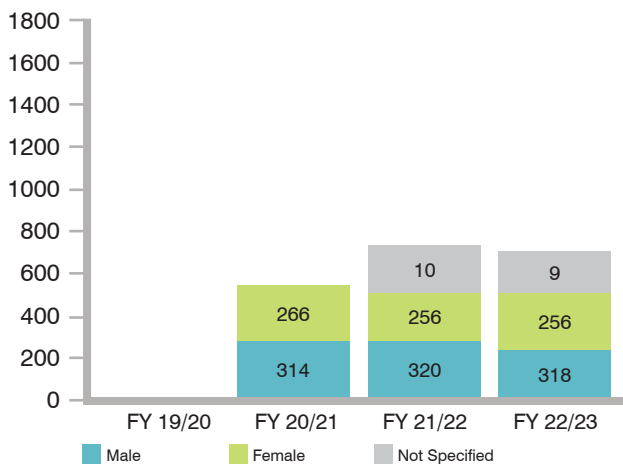

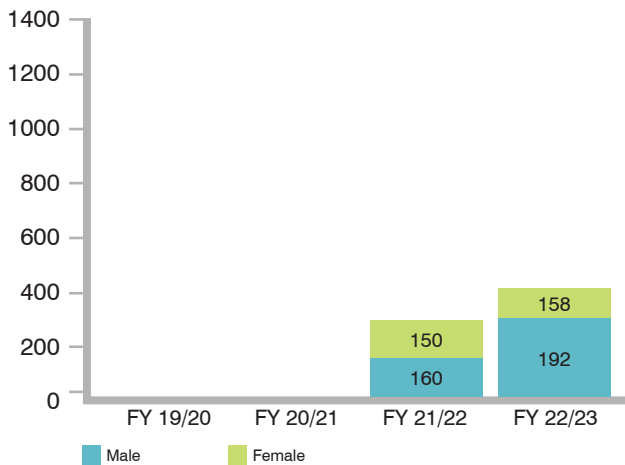

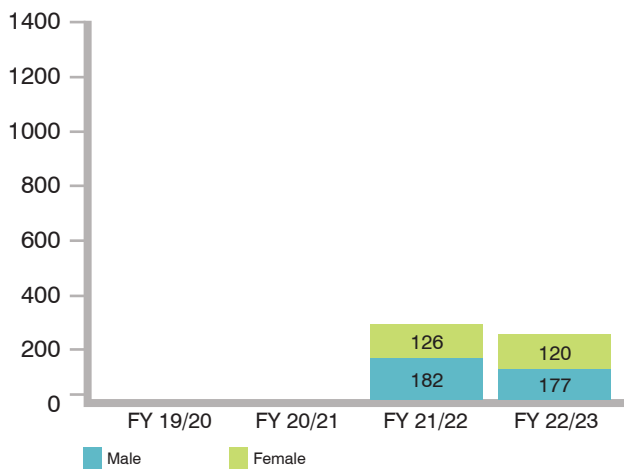
