A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on January 23rd to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on January 24th.

MINUTES/TRANSCRIPT

On a motion by Commissioner Ralston, seconded by Commissioner Dermody, the Board unanimously approved the minutes and transcripts of the October 18, 2023, meeting.

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole, began his report by sharing the key data regarding gaming revenue produced by the Pennsylvania gaming industry in calendar year 2023. He explained the total gaming revenue from all sources of gaming activity, under the PGCB's regulatory oversight, reached almost \$5.7 billion in 2023, which Kevin stated was a 9.3% increase from total gaming revenue of \$5.2 billion in 2022.

He further stated land-based casinos generated \$3.4 billion in gaming revenue due to the play of slot machines, table games and poker. Which Kevin explained gave land-based casinos a 3% increase in revenue, compared to 2022, and a 60.3% market share of total gaming revenue for 2023.

Kevin then spoke about online casino games, which simulated slot machines, table games and poker, amounted to \$1.7 billion in gaming revenue. He explained this was a 31% increase from 2022, along with a market share of 30.57% for 2023. Kevin also shared the sports wagering revenue for calendar year 2023 and how it amounted to \$459 million, for a 14.31% increase over 2022 and a market share of 8.05% for 2023.

Next, he talked about the VGT revenue at licensed truck stops and Fantasy Contests revenue, which amounted to \$61 million, a decrease of 5% from 2022, and a market share of 1.08% for 2023.

Kevin also stated the resulting gaming tax revenue to the Commonwealth of Pennsylvania for calendar year 2023 was \$2.34 billion, the highest to date, breaking the previous high of \$2.12 billion in 2022. He further explained this gaming tax revenue is distributed to a cross-section of legislatively approved entities, which included The PA Race Horse Development Fund, The Economic Development Trust Fund, The Commonwealth Financing Authority, and Local Share Assessment County Grants, along with a few others. Kevin explained these figures represent a few important observations including online casino gaming has grown exponentially in its first 5 years, land-based gaming has stayed strong, and sports wagering revenue, also in its first 5 years, has continued to grow on an annual basis. All of this, Mr. O'Toole continued, Pennsylvanians continue to show that licensed and regulated gambling is an activity they enjoy participating in.

Kevin concluded his report by stating that with starting into the new year, the Pennsylvania Gaming Control Board and its staff will continue to do its part to ensure that tested and approved games, whether in a casino facility or online, will protect the public and insure fairness in all gambling.

OFFICE OF FINANCIAL MANAGEMENT

Director of Budget, Dave Rhen, began his Fiscal Year 2023-2024 Second Quarter Budget Report by reporting the Board expenses for the first half of the fiscal year through December 31, 2023. He stated for the first half of the fiscal year, the expenses were \$23,206,375 with 92% or \$21,254,572 for payroll while the remaining 8% or \$1,051,803 were for operating expenditures. Overall, Dave explained, expenditures were \$2,034,796 or 9.6% higher than last year's expenditures through the first half. He went on to state that included a \$2,160,250 increase in personnel expenses and a decrease of \$125,453 in operating expenses.

Mr. Rhen also said payroll expenses were up primarily due to an increase in the employee count and union negotiated raises. The total payroll costs of \$21,254,572 consisted of salary costs of \$12,522,508 along with benefit costs of \$8,710,181 and retirement leave payouts of \$21,884, he explained.

Dave continued with explaining operating expenses through December were \$1,951,803 which real estate and parking leases were the largest operating cost of \$814,514. He went on to say \$384,205 operating costs were for subscriptions and database services, while \$190,306 for interagency billings. Along with these two operating costs, there was also \$139,885 spent on Directors and Officers Insurance and \$125,987 for software licenses.
