DESCRIPTION OF BUSINESS

The Mohegan Tribal Gaming Authority, the parent of Mohegan Gaming Advisors, was formed in 1995 and opened Mohegan Sun Connecticut in 1996. Our destination resort casino offers some of New England's finest dining, hotel accommodations, retail shopping, live entertainment and sporting events, in addition to more than 300,000 square feet of gaming space within three casinos. Mohegan Sun Connecticut also features a family entertainment facility, day spa, convention and meeting facilities, three entertainment venues with seating from 300 to 10,000, a 130,000 square foot retail shopping experience, 40 restaurants, bars and lounges and a state —of-the-art poker room. Our 10,000-seat arena is also home to our WNBA team, the Connecticut Sun.

Mohegan Sun at Pocono Downs was created through acquisition in 2005 and, in November 2006, became the first casino to open in the Commonwealth of Pennsylvania. It is located on 400 acres in Plains Township, and is one of the most distinctive and successful entertainment, gaming, shopping and dining destinations in the state. It features over 55,000 square feet of gaming space, approximately 2,300 slot machines and other electronic games, and over 80 table games. Mohegan Sun at Pocono Downs also features an array of retail shops and more than 10 restaurant, food and beverage outlets. Live harness racing is conducted eight months of the year on a 5/8 mile oval track.
