REQUEST FOR A REDUCED LICENSE FEE FOR A TABLE GAME MANUFACTURER OR TABLE GAME SUPPLIER

AN APPLICANT FOR A TABLE GAME MANUFACTURER OR TABLE GAME SUPPLIER LICENSE MAY OBTAIN A MODIFIED LICENSE FEE SO LONG AS THE FOLLOWING CONDITIONS ARE MET: (1) THE MANUFACTURER OR SUPPLIER COMPLETES A "REQUEST FOR A REDUCED LICENSE FEE FORM" WITH ITS APPLICATION SUBMISSION AND PROVIDES ALL SUPPLEMENTAL DOCUMENTATION TO SUBSTANTIATE THE REQUEST; (2) THE REQUEST IS NOT OBJECTED TO BY THE OFFICE OF ENFORCEMENT COUNSEL OR THE BUREAU OF LICENSING; AND (3) THE BOARD APPROVES THE RECOMMENDED FEE MODIFICATION.

ANY REDUCTION IN THE LICENSE FEE APPROVED BY THE BOARD WILL HAVE NO IMPACT ON REQUIRED APPLICATIONS OR APPLICATION/INVESTIGATORY FEES.

A LICENSED TABLE GAME MANUFACTURER OR SUPPLIER THAT IS GRANTED A FEE REDUCTION MUST PROVIDE QUARTERLY SALES REPORTS TO THE BUREAU OF LICENSING. A CONDITIONALLY LICENSED TABLE GAME MANUFACTURER OR SUPPLIER THAT IS GRANTED A FEE REDUCTION MUST PROVIDE MONTHLY SALES REPORTS TO THE BUREAU OF LICENSING. THE MANUFACTURER OR SUPPLIER MUST PROVIDE, AS PART OF ITS AUDITED FINANCIALS, A REPORT THAT SUMMARIZES PENNSYLVANIA GAMING RELATED SALES.

SHOULD A TABLE GAME MANUFACTURER OR SUPPLIER THAT IS GRANTED A REDUCED FEE EXCEED ITS PROJECTED GROSS SALES DOLLAR THRESHOLD, THE LICENSEE WILL BE REQUIRED TO PAY THE ADDITIONAL LICENSE FEE AS OUTLINED ON THE SCHEDULE BELOW.

THE BELOW CHART WILL BE USED BY THE BUREAU OF LICENSING IN MAKING A RECOMMENDATION FOR A REDUCED LICENSE FEE TO THE BOARD. THE RECOMMENDED REDUCED LICENSE FEE WILL BE BASED ON THE PROJECTED GROSS SALES FOR THE NEXT 12 MONTHS PROVIDED BY THE APPLICANT.
