In Re: The Matter of Temporary Principal and Key Employee Credentials

ORDER

And now, this 20th day of March 2024, the Pennsylvania Gaming Control Board (Board), having received the reports of the Bureau of Licensing and Office of Enforcement Counsel, on behalf of the Bureau of Investigations and Enforcement, finds that the principal and key employees on the list attached hereto satisfy the requirements to receive temporary credentials as follows:

1. The principal and key employees submitted applications and caused application fees to be submitted to the Board.

2. A criminal history and credit check revealed no issues precluding issuance of temporary credentials.

3. Investigation of these applicants is ongoing.

4. The Board has delegated authority to the Director of Licensing to issue principal and key employee temporary credentials, provided a list of the principal and key employees is regularly presented to the Board for approval.

5. The temporary credentials issued are nontransferable.

6. The temporary credentials are void 270 days after issuance unless extended by the Bureau of Licensing.


7. Pursuant to 58 Pa. Code § 421a.1, an approval issued by the Board is a revocable privilege.

8. Pursuant to 4 Pa.C.S. § 1202(a), the Board has jurisdiction over every aspect of the authorization, operation and play of slot machines and table games in this Commonwealth.

9. Pursuant to 4 Pa.C.S. § 1202(b)(14), the Board has authority to issue, approve, renew, revoke, suspend, condition or deny issuance or renewal of any principal or key employee license.

IT IS ORDERED that the Board approves the issuance of temporary credentials to the principal and key employees on the list attached hereto provided the principal and key employees agree to the Board's Statement of Conditions as evidenced by the signing of said conditions.
