

<u>PETITION TO PERMIT THE SURRENDER</u> OF THE PRINCIPAL LICENSE OF JEFFREY TRATTNER

Wind Creek Bethlehem LLC (WCB), with its principal place of business located at 77 Wind Creek Boulevard, Bethlehem, Northampton County, Commonwealth of Pennsylvania, by Petition to Permit the Surrender of the Principal License of Jeffrey Trattner (Trattner), respectfully represents as follows:

- WCB is the holder of a Category 2 Slot Operator License pursuant to 4 Pa. Code §1304, License No. 1353-4, which carries a current expiration date of May 29, 2023 and which its Renewal application is currently pending with the Pennsylvania Gaming Control Board (PGCB).
- PCI Gaming Authority d/b/a Wind Creek Hospitality ("PCI"), an instrumentality of the Poarch Band of Creek Indians (the "Tribe"), owns all of the membership interests of WCB. PCI and the Tribe are licensed as affiliates of WCB. Their applications for Renewal are also pending with the PGCB.
- 3. Pursuant to the Pennsylvania Race Horse Development and Gaming Act (Act) and the regulations promulgated thereunder, an application to be licensed as a Principal, as

required by 58 Pa. Code § 433a.2 (b), was filed for Trattner as required due to his

position as Assistant Attorney General of Gaming Operations for PCI Gaming Authority.

4. On June 12, 2019, Trattner's Principal License was approved by the Pennsylvania

Gaming Control Board (Board) and assigned Gaming Identification Number 108368-1.

Trattner's Principal License holds an expiration date of June 11, 2024.

5. On or about December 13, 2023, the PGCB was informed that Trattner's job duties had

changed, and he was no longer in a Principal licensee position. He was not required to

file a renewal application.

6. Further, on or about February 26, 2024, Trattner is no longer employed with PCI Gaming

Authority and is no longer affiliated with WCB.

7. As such, as of the effective date, Trattner no longer holds the position that required him

to be licensed as a Principal per 58 Pa. Code § 433a.2 (b), and he no longer is required to

be licensed as a Principal per 58 Pa. Code § 433a.2 (b).

WHEREFORE, Wind Creek Bethlehem LLC respectfully requests that the Board permit

the surrender of the Principal License of Jeffrey Trattner, ID No. 108368-1, as of the Effective

Date.
