
## COMMONWEALTH OF PENNSYLVANIA PENNSYLVANIA GAMING CONTROL BOARD



In Re: The Matter of Principals, Key Employees and Qualifiers

## **ORDER**

And now, this 24<sup>th</sup> day of January 2024, the Pennsylvania Gaming Control Board (the "Board"), based on its review of the reports of the Bureau of Licensing and Office of Enforcement Counsel, on behalf of the Bureau of Investigations and Enforcement, finds that the applicants on the list attached hereto satisfy the requirements to receive licenses and/or qualifications pursuant to Act 42 of 2017, as applicable, to include Part I, Chapter 3 (Fantasy Contest), 4 Pa.C.S. §§ 301-342; Part II (Gaming), 4 Pa.C.S. §§ 1101-1904, as amended; and Part III (Video Gaming), 4 Pa.C.S. §§ 3101-4506, (collectively, the "Act") as follows:

- 1. The applicants identified on the attached list submitted applications and caused application fees to be submitted to the Board.
- 2. Each of the identified entities and/or individuals on the attached list have proven that they are of good character, honesty and integrity and are eligible to receive licenses or qualifications.
- 3. The licenses and qualifications issued pursuant to this Order are valid for a period of five years and are nontransferable.
- 4. Pursuant to 58 Pa. Code § 421a.1 (relating to general requirements), a license or other approval issued by the Board is a revocable privilege.
- 5. Pursuant to 4 Pa.C.S. §§ 311(a), 1202(a), and 3301(a) (relating to general powers), the Board has sole regulatory authority over every aspect of the authorization, operation and play of fantasy contests; slot machines, table games, interactive gaming, sports wagering; and video gaming, respectively, in this Commonwealth.

6. The Board has authority and retains the right to issue, approve, renew, revoke,

suspend, condition or deny issuance or renewal of any license or qualification for any violation

of the Act or Board regulations.

7. Licenses and qualifications are conditioned on the applicants' satisfaction of the

following criteria:

a. To cause the payment of any outstanding fees.

b. The applicants are in compliance with each condition set by the Board or

contained in the Act, including agreeing to the Board's conditions of licensure as evidenced by

the signing of a Statement of Conditions.

WHEREFORE, IT IS ORDERED that the Board approves the issuance of the licenses

and qualifications on the attached list, subject to satisfaction of the above criteria and continuing

compliance with the Act, the Board's regulations promulgated thereunder, including notice and

filing requirements.
