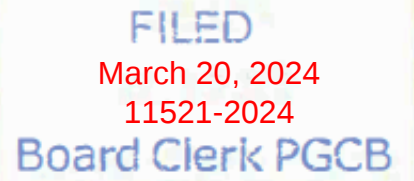

In Re: The Matter of Occupation Permits and Registrations

ORDER

And now, this 20th day of March 2024, the Pennsylvania Gaming Control Board (Board), having been notified that neither the Bureau of Licensing nor the Office of Enforcement Counsel have any objection, finds that the applicants on the lists attached hereto satisfy the requirements to receive occupation permits, temporary occupation permits or registrations as follows:

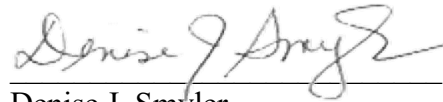
1. The Board has delegated authority to the Director of Licensing to issue occupation permits and registrations, provided a list of those permits and registrations is regularly presented to the Board for approval.
2. The applicants on the lists attached hereto submitted applications and caused application fees to be submitted to the Board.
3. The Board finds that, based on a review of the applicants by the Bureau of Investigations and Enforcement, the applicants on the lists attached hereto have proven that they are of good character, honesty and integrity and are eligible and suitable to receive occupation permits or registrations.
4. The Board also finds that based on preliminary background investigation, the applicants on the attached supplemental list are suitable to hold temporary occupation permits.
5. An occupation permit, temporary occupation permit or registration is a nontransferable, revocable privilege.
6. Pursuant to 4 Pa.C.S. § 1202(a), the Board has jurisdiction over every aspect of the authorization, operation and play of slot machines and table games in this Commonwealth.

7. Pursuant to 4 Pa.C.S. §§ 1202(b)(14) and (15), the Board has authority to issue, approve, renew, revoke, suspend, condition or deny issuance or renewal of any occupation permit or registration.

8. The aforementioned gaming and non-gaming employees agree to the Board's Statement of Conditions as evidenced by their acknowledgement of the conditions in their applications.

IT IS ORDERED that the Board approves the lists attached hereto, submitted by the Bureau of Licensing, for the issuance of occupation permits, temporary occupation permits and registrations.
