In Re: The Matter of Withdrawing Gaming Employee Permittee and Non-Gaming Employee Registration Applications

<u>ORDER</u>

And now, this 21st day of February 2024, the Pennsylvania Gaming Control Board (Board), having received the report of the Bureau of Licensing, finds that the gaming and non-gaming employees on the list attached hereto no longer require occupation permits or registrations as follows:

1. The gaming and non-gaming employees submitted applications and caused application fees to be submitted to the Board.

2. The occupation permits or registrations are no longer required due to various reasons, including but not limited to a rescinded job offer; failure of the employee to report for work; or the employee's acceptance of a job with another employer.

3. Because the occupation permit or registration is no longer required, requests for withdrawals have been submitted to the Pennsylvania Gaming Control Board.

4. After review of the requests for withdrawal, neither the Bureau of Licensing nor the Office of Enforcement Counsel objects to the withdrawals.

5. The Board has delegated authority to the Director of Licensing to grant routine withdrawal requests for occupation permit or registration applications provided the list of granted withdrawals is regularly presented to the Board for approval.

6. Pursuant to 4 Pa.C.S. § 1202(a), the Board has jurisdiction over every aspect of the authorization, operation and play of slot machines and table games in this Commonwealth.

IT IS ORDERED that the Board approves the attached list submitted by the Bureau of Licensing for the withdrawal of applications for occupation permits and registrations.
