PURSUANT TO 4 PA. C.S. §1103, A LICENSED ENTITY REPRESENTATIVE IS DEFINED AS INCLUDING ANY PERSON, INCLUDING AN ATTORNEY, AGENT OR LOBBYIST, ACTING ON BEHALF OF OR AUTHORIZED TO REPRESENT THE INTEREST OF ANY APPLICANT, LICENSEE, PERMITEE OR OTHER PERSON AUTHORIZED BY THE PENNSYLVANIA GAMING CONTROL BOARD (PGCB) TO ENGAGE IN ANY ACT OR ACTIVITY REGARDING ANY MATTER BEFORE, OR WHICH MAY REASONABLY BE EXPECTED TO COME BEFORE THE PGCB.
