MR. O'TOOLE: Good morning, everyone.

I'm Kevin O'Toole, the Executive Director of the Pennsylvania Gaming Control Board. We are here this morning as a continuation of the proceeding that commenced yesterday morning.

This is the - Auction Number Four of the initial round of auctions to establish Category Four locations in compliance with Act 42 of the Gambling Expansion Bill.

Yesterday morning we received two bids to bid on the lots. And we also received two affidavit location envelopes. The bid envelopes were opened and the higher of the two bids was announced yesterday.

At that time we also opened the affidavit location envelopes of the higher bid and we announced that location with the coordinates of latitude and longitude.

Subsequent to that proceeding, it was determined that the coordinates established a Category Four location that intruded upon the Category Four location that had been awarded in Auction Number Three, which occurred two weeks ago.

1 forth in their affidavit, is latitude 40.075975,
2 longitude, negative 77.403075. So I'll repeat those
3 coordinates.

4 The latitude is 40.075975, and the
5 longitude is negative 77.403075. Those coordinates
6 are associated with the municipality of South Newton
7 in the County of Cumberland.

8 So just to repeat, the winning bid at
9 Auction Number Four is \$8,111,000. The winning bidder
10 is Greenwood Gaming and Entertainment, Inc. And the
11 latitude, longitude, municipality and county as I
12 previously read.

13 So that concludes the proceeding today
14 for Auction Number Four. Before we conclude, I would
15 like to note that the winning bid amount is due to be
16 paid by 4:00 p.m. on Monday, February 26. And that
17 our next auction will commence at 10:00 a.m. on March
18 the 7th prior to the Gaming Control Board's public
19 meeting on that date. Thank you very much.


