P R O C E E D I N G S

MR. O'TOOLE: Good morning, everyone.

I'm Kevin O'Toole, the Executive
Director of the Pennsylvania Gaming Control Board.

We're here this morning to conduct the
fifth auction in the initial round of auctions for
Category 4 Locations, pursuant to Act 42 of 2017.

So I would like to ask if everyone who
is eligible to participate in the auction today and
who desires to place a bid, if they haven't come up to
the front here with their Bid Envelopes and their
Affidavit/Location Envelopes, now would be the time.

Do we have anyone in the audience that
would like to bring bids up?

Let the record reflect that nobody
approached the podium this morning.

So having received no bids in the
fifth auction of the initial round, according to Act
42 of 2017, the Gaming Control Board will commence the
second round of auctions. Act 42 refers to that round
as subsequent auctions.

So subsequent auctions are - we'll
open up the auction process to Category 3 Slot Machine
Licensees. And it also allows Category 1 and Category

1 2 Slot Machine Licensees to also bid.

2 And that would also include any
3 Category 1 or Category 2 Slot Machine Licensee who was
4 a winning bidder in the initial auctions.

5 So just to summarize, the subsequent
6 auctions allow Category 1, Category 2 and Category 3
7 Slot Machine Licensees to bid for Category 4
8 locations. And that includes any winners in the
9 initial round.

10 So I'd like to announce that our first
11 auction in the subsequent round will be held on
12 Wednesday, March the 21st at 10:00 a.m. in the Board's
13 Public Meeting Room, where we are this morning. And
14 it will occur immediately prior to the Board's Public
15 Meeting on that date.

16 So with that, I will close today's
17 proceeding. Thank you.
