# PGCB RESOLUTION NO. 2005-3 REG – Adoption of Temporary Manufacturer Regulations

Motion Made: Board Member Colins Seconded: Board Member Rivers

Whereas On July 5, 2004, the Pennsylvania General Assembly enacted the

Pennsylvania Race Horse Development and Gaming Act, establishing the Pennsylvania Gaming Control Board as the primary regulatory agency

charged with the responsibility of implementing and overseeing slot machine gaming in the Commonwealth; and

Whereas

The Act authorizes the Board to adopt "temporary" regulations in order to facilitate the prompt implementation of the Act during the two years following the Act's effective date; and

Whereas The Board has developed draft temporary regulations for general

administrative practice and procedure before the Board and for licensing

standards for gaming equipment manufacturers; and

Whereas The public has had an opportunity to comment on the draft temporary

regulations, and the Board has incorporated appropriate public comments

into the regulations; and

Whereas The Board's final temporary regulations are designated as Title 58 Recreation, Part VII Gaming Control Board:

- Subpart A General Provisions, specifically Chapter 401 Preliminary Provisions; Chapter 403 Board Operations and Organization; Chapter 407 Public Access to Board Records; and
- Subpart B Licensing, Registering and Permitting, specifically Chapter 421 General Provisions; Chapter 423 Applications; Chapter 427 Manufacturer Licenses; Chapter 433 License Renewal as applies to manufacturers; and Chapter 435 Employees as applies to manufacturers; and
- Subpart D Recordkeeping, specifically Chapter 451 Licensee Recordkeeping Requirements; and
- Subpart E Slot Machine Testing and Certification, specifically Chapter 461 Slot Machine Testing and Certification Requirements; and
- Subpart F Fees, specifically Chapter 471 Filing Fees as applies to manufacturers; and
- Subpart G Minority and Women's Business Enterprises, specifically Chapter 481 General Provisions; and
- Subpart H Practice and Procedure, specifically Chapter 491 General Rules of Practice; Chapter 495 Documentary Filings, Chapter 497 Time, and Chapter 499 Representation Before the Board; and

Whereas The Board reserves the right to amend the temporary regulations as it

deems necessary in accordance with the purpose of the Act and in order to

further the intent of the Act; be it

RESOLVED That the Board adopts the draft regulations as its temporary regulations for

general administrative practice and procedure before the Board and for

licensing standards for gaming equipment manufacturers.
