Meeting of the Board November 4, 2009 Minutes

A meeting of the Pennsylvania Gaming Control Board was held on November 4, 2009 in the State Museum Auditorium, Harrisburg, PA. The meeting began at 10:00 a.m.

A quorum of the Board being present, Chairman Fajt called the meeting to order.

ANNOUNCEMENTS

Chairman Fajt announced that the Board held an Executive session on November 3, 2009 to discuss personnel issues, to conduct quasi-judicial deliberations relating to matters pending before the Board and to consult with counsel regarding privileged and confidential agency business.

Chairman Fajt also announced that the PGCB would be holding a hearing on Thursday, November 12th to gather evidence, including public comment on the renewal of the Category 1 Slot Machine Operator's License of Mountainview Thoroughbred Racing Association.

MINUTES AND TRANSCRIPTS

On a motion by Board Member Sojka, seconded by Board Member Rivers, the minutes and transcript of the September 23, 2009 meeting were unanimously approved.

EXECUTIVE DIRECTOR'S REPORT

Mr. Kevin O'Toole, Executive Director reported that slot machine revenue continues to show growth at the nine operating casinos in Pennsylvania. He stated that for the month of October 2009, gross revenue through the play of slot machines rose almost 32 percent over the previous year. In October 2009, the nine operating casinos generated \$177 million in gross revenue compared to \$134 million in October 2008 when seven casinos were in operation. This growth in revenue resulted in tax collections of \$97.4 million this past month. Mr. O'Toole also commented on the most recent press release posted to the Board's web site by the Communications Department. This press release highlights the numerous municipal and county projects that have been made possible through funds received from the local share assessments of the slot machines gross terminal revenue. He congratulated the Communications department, led by Doug Harbach, for doing an outstanding job of communicating to all interested parties the numerous benefits that have resulted from the casino industry in the Commonwealth of Pennsylvania.

PGCB RESOLUTION NO. 2009-7-EXE – Board Member Sanford Rivers

WHEREAS, Sanford Rivers was appointed by Governor Edward G. Rendell on August 15, 2004 as an initial member of the Pennsylvania Gaming Control Board; and

WHEREAS, Commissioner Rivers was sworn in and presided over the Board's first meeting on December 14, 2004; and

WHEREAS, the Board established from the ground up the first state agency in more than 30 years, created a comprehensive body of regulations to ensure the integrity of gaming and investigated thousands of individuals for licensure; and

WHEREAS, after a licensing process that included 18 days of public input hearings across the state as well as suitability hearings in Harrisburg, the Board voted on September 27, 2006 to award its first conditional Category 1 operator licenses; and

WHEREAS, on November 14, 2006, less than two years after the Board held its first meeting, Pennsylvania's first licensed gaming facility, Mohegan Sun at Pocono Downs, opened to the general public; and

WHEREAS, the Board voted on December 20, 2006 to award 11 permanent Category 1 and Category 2 operator licenses; and

WHEREAS, nine of the facilities are now operating and providing employment for thousands of Pennsylvanians; and

WHEREAS, as a result of the Board's actions, property and wage tax relief is no longer a wish but a reality; and

WHEREAS, Pennsylvania's horse racing industry is showing new life thanks to an injection of new dollars; and

WHEREAS, as an initial member of the Pennsylvania Gaming Control Board, Commissioner Rivers led the effort to turn mere words on paper into a new multi-billion dollar industry for the Commonwealth; be it

RESOLVED that the Pennsylvania Gaming Control Board proudly recognizes Commissioner Rivers exemplary record of service and leadership and wishes him the very best in all of his future endeavors.
