On a motion by Commissioner Kernodle, seconded by Commissioner Logan, the Board unanimously approved the transcript of the September 30, 2020 meeting.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole reported to the Board that Casino licensee Stadium Casino has successfully opened the first Category 4 casino facility located in Greensburg, Pennsylvania, Westmoreland County. A 2-day test period was completed on Saturday, November 14th and Sunday, November 15th. Our Director of the Bureau of Casino Compliance, Chris Schroder, and his opening team observed the operation of 750 slot machines and 30 table games and reported that the property followed required procedures and internal controls and was satisfactorily prepared to open the casino.

Mr. O'Toole further commented that Live! Casino Pittsburgh also opened its Retail Sportsbook with sports wagering Operator, FanDuel. All aspects of the Retail Sportsbook were observed by Board personnel during last weekend's 2-day test period.

Mr. O'Toole also stated that all gaming revenues are to be donated to 2 charities by Stadium Casino after required gaming taxes are paid.

Finally, which was just recently completed, the opening at the Wind Creek Casino Hotel in Bethlehem, Pennsylvania. Wind Creek opened its Retail Sportsbook for a 2-day test period on Monday and Tuesday of this week with the assistance of the sports wagering operator, BetFred Sports. All aspects of the Retail Sportsbook appeared to run smoothly, but Board staff's evaluation would not be completed until early this afternoon.
