**EXECUTIVE DIRECTOR'S REPORT**

Kevin O'Toole reported to the Board that on February 9, 2021, the Office of Communications issued a press release announcing the preliminary figures associated with the sports wagers made by betters in Pennsylvania on last Sunday's Super Bowl. These figures were very good, 53.6 million in handle on the Super Bowl game which produced 9.4 million dollars in gross sports wagering revenue. The Super Bowl as a successful betting event, reflects positively on the continuing growth of online gaming in Pennsylvania, both on sporting events and on casino games. Although the final figures for January 2021 are still pending our receipt of final monthly reports from the industry, the growth in online wagering will continue in a manner that benefits the operators and the casino licensees. The Board's press release with those figures for January of 2021 will be issued early next week.
