BOARD RESOLUTION

PGCB MOTION NO. 2021-78 EXE

On a motion by Commissioner Mustio, seconded by Commissioner Logan, the Board unanimously approved a resolution commemorating the service of Commissioner Merritt C. Reitzel to the Board.

ANNOUNCEMENTS

Chairman Barasch announced that the Board held an Executive Session telephonically on March 16th to discuss personnel matters and to conduct quasi-judicial deliberations relating to matters coming before the Board on March 17th.

PUBLIC HEARING

GW Cumberland OP Co. – Petition to Declare the Scope of the Traffic Impact Study Relative to its Category 4 Slot Machine License Application (OHA No. 9628-2021) : CW Cumberland OP Co.'s public hearing was scheduled for today, but they submitted a proposed stipulation of settlement to resolve this matter. CW Cumberland agrees to study the expanded area requested by the Office of Enforcement Counsel and would only be responsible for a pro rata portion of any improvements needed in the expanded area. The parties also agree that it would be appropriate to put a cap on the amount of any monetary liabilities. GW Cumberland wanted the monetary liability established today, but knew the Board was unwilling to do that and remained willing to resolve the matter pursuant to the other terms of the settlement agreement. The settlement agreement, modified, was up for vote during the Office of Chief Counsel's portion of the meeting.

MINUTES/TRANSCRIPT

On a motion by Commissioner Logan, seconded by Commissioner Kernodle, the Board unanimously approved the minutes and transcript of the January 13, 2021 meeting.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole began by welcoming Commissioners Regan and Dermody to the Board.

Mr. O'Toole reported that the Governor announced several initiatives to reduce the mitigation steps that have been in place for about 9 months. The initiatives that will benefit casinos relate to increasing capacity for restaurant seating to 75% and allowing alcohol service on a broader scale than previously.

Additionally, Mr. O'Toole reported that on March 16, 2021, Board staff issued its press release for the month of February detailing the revenue figures for all gaming activity that the Board regulates. For the second month in a row total revenue from all sources exceeded \$300,000,000. With the removal of restrictions as noted earlier, our land-based casinos will continue to get closer to their benchmarks for measuring success.
