ANNOUNCEMENTS

Chairman Barasch announced that the Board held an Executive Session telephonically on April 20th to discuss personnel matters and to conduct quasi-judicial deliberations relating to matters coming before the Board on April 21st.

Additionally, Chairman Barasch announced that the Board had scheduled a Public Input Hearing relative to the Category 4 casino proposed for Shippensburg Township, Cumberland County, by GW Cumberland OP. Co., an affiliate of the operators of Parx Casino. The casino is proposed at the former site of a Lowes Home Improvement Store, at 250 Conestoga Drive. The Public Input Hearing is scheduled for May 20, 2021, beginning at 4 p.m., at the Luhrs Performing Arts Center on the campus of Shippensburg University. The Board will also provide remote participation for the hearing.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole asked the Board to ratify a contract between the Board and TruView BSI, LLC. TruView is a company in the business of providing background screening services and the contract in question will allow the Bureau of Investigations and Enforcement to use its services.

With the term of the Board's contract with its prior vendor for background screening coming to term, a Request for Proposals was prepared by Board staff and published on October 19, 2020. From that request, 5 bidders submitted offers, which were each blindly evaluated and scored by a committee comprised of Board staff from BIE and IT. Ultimately, TruView's bid was determined to be the best for the Board and TruView entered into final contract negotiations with the Office of Chief Counsel, which were successfully concluded in mid-March.
