- 18 problems, and various other construction matters, the
- 19 current projected date at the time for the casino
- 20 portion was the second quarter of '09, followed three
- 21 months later with the same delay between casino and
- 22 hotel as we originally projected.
- 23 The next day, the Board -- at that hearing, the
- 24 Board granted us the license. It was contemplated when
- 25 Mr. DeSalvio and I appeared in front of the Board in
