We moved to the Bellefonte area from Western NY about 4 years ago. As you are aware, there are many Indian Nation operated casino's in NY. I understand that they do not pay taxes to NYS at the same rate as other business', so this may not be a fair comparison to one in the Nittany Mall.

One such that came to mind after reading a letter in the Lockhaven Express was the Turning Stone casino. There was a paper written some years ago (2005) about the effects of the casino on the area around the casino.

The summary of the paper indicates that although there were positive impacts of employment, it came at a cost of increased crime rates in the area. This was in 2005. I don't know if things have progressed or regressed since then. I suspect you are familiar with this study and maybe others.

Dear Board--

As a citizen of State College, I write to voice my opposition to the proposed casino at the Nittany Mall. My opposition is based on a number of concerns:

- casino gambling negatively impacts those most vulnerable: people who hope to "strike it rich" to escape their humble means. That never works out for these seniors on limited income, or folks living on welfare--the "house" ultimately wins, taking their much-needed money. Even those of means end up losing, wasting their money on an incredibly unhealthy form of entertainment.
- point #1 is exacerbated by the very real phenomenon of gambling addiction. I once watched one of my Penn State students, while we attended a conference in Atlantic City, fall victim to slots. He'd never been close to a gambling opportunity before; and he was so instantly "hooked" that it took a lot of effort for his classmates to pry him away.
- the location of a casino in a college town just doubles the potential trouble. Students with limited time (they're supposed to be studying! and having a college experience!) and frequently limited means will be far too easily sucked into this "amusement opportunity," only to lose both time and money.

The bottom line is that casinos are predatory, a benefit only for the people who run them. I'm ashamed that a member of Penn State's Board of Trustees is trying to open a casino here. Its impact on our community will be negative, and Lubert will bear that as his legacy.

Dear PA Gaming Control Board,

I apologize for not sending this e-mail prior to the deadline for the hearing about the proposed casino at Nittany Mall, but I only became aware of this issue last night (8/28/2021). I hope that my input can still be incorporated into the decision making process regarding the construction of this casino.

I am **strongly opposed** to the construction of a casino at the Nittany Mall. At a fundamental level, every casino accrues benefits to its owners by extracting money and imposing negative externalities on the community in which it is located. Although a casino may generate a small number of jobs and slightly increase tax revenue in the municipality in which it is located, these benefits are almost worthless when juxtaposed with the costs borne by the community. Gambling addiction is a serious problem, and the increased tax revenue that is brought in by the casino will not compensate these addicts or their families for what they will have to suffer both now and in the future. Likewise, the innocent victims of the increased crime that comes with the casino will not be made whole because the casino has created a small number of jobs.

The impact study associated with this proposed casino (https://gamingcontrolboard.pa.gov/files/impact_reports/SC_Gaming_OpCo_LLC/SC_Gaming_OpCo_LLC_Local_Impact_Report.pdf) is a textbook example of motivated reasoning and it ignores just about everything except short-term effects on aggregated economic metrics. For example, how does the long-term loss of economic productivity from an individual who is injured or killed as a result of casino-related crime factor into this analysis? How does the study account for the long-term difference in economic output because a gambling-addicted parent spends his time and his child's college fund on gambling instead of investing those essential values in his child's education? How does the study account for the long-term impact on property values when local residents spend their money on gambling instead of on maintaining and upgrading their homes? And how does the study account for the non-economic effects of opening a casino such as the psychological suffering and decrease in quality of life for people who put themselves into financial distress because they cannot stop gambling?

The short answer is that none of these costs are included in the analysis. If the long-term and non-financial costs of bringing the casino to the Nittany Mall were actually included in the analysis, the impact study would clearly show that having a casino in our community is a terrible idea.

I strongly urge you to reject the application for the construction of the casino at the Nittany Mall.

This has been a great college town in which to raise our family. Unfortunately it has had some challenges due to the influx of drugs and alcohol that tend to be targeted on our youth and young adults. State College seeks to increase tourism to offset other expenses and to keep taxes lower which I truly appreciate. My concern is that a Casino would really change the culture of this community.
