AUTHORITY



- 10/05/2018—BOARD APPROVES MTRA SPORTS WAGERING CERTIFICATE (1ST LAND-BASED SPORTS BOOK IN PA OPENED 11/17/2018)
- Under the Act, a slot machine licensee who has petitioned for and holds a sports wagering certificate may be authorized to conduct sports wagering at (i) its licensed facility, (ii) a temporary facility, (iii) at nonprimary locations if the sports wagering certificate holder is a Category 1 slot machine licensee and a licensed racing entity, and/or (iv) through an internet-based system. 4 Pa. C.S. §§ 13C11 and 13C21(c).
- THE BOARD'S REGULATIONS FURTHER CONFIRM THAT LAND-BASED SPORTS WAGERING MAY BE CONDUCTED "AT A NONPRIMARY LOCATION OF A CATEGORY 1 SLOT MACHINE LICENSEE..." WHICH HOLDS A SPORTS WAGERING CERTIFICATE. 58 Pa. Code § 1401.5(b)(3).
