Good afternoon members of the PA Gaming Control Board (PGCB), I'm providing this written testimony to voice my strong opposition to the proposed Category 4 casino in College Township, PA. If I were to appear in person at the public input hearing on August 16, 2021 it would not be possible to cover the specific details of my opposition within the five-minute allotted time. I'm confident that each member of the PGCB is already aware of the top reasons of opposition to any proposed casino in Pennsylvania (i.e., severe financial impact on families, impact on nearby property values, increase in crime and traffic, etc.). Each of you has already heard all of this with the approval process of any proposed casino. I could outline in detail many gambling-related stories of total chaos, but you are already familiar with all of that. Rather than whine here about my personal opposition to the proposed casino, I would like to focus on a specific portion of the casino application itself as well as the sealed-bid process used by the PGCB where ONLY the dollar amount of the winning bid is disclosed to the public. Regarding the bidding process, as long as the Chairman of the PA Gaming Control Board and the other decision-makers at the PGCB are aware of the exact dollar amounts of each bid received I would then concur with moving forward with the casino application review process. The specific portion of the casino application I'll focus on here is Appendix 35 where the applicant is requested to provide details of a compulsive or problem gambling plan. If there was ever a perfect example of a boilerplate `copy and paste` reply to an application question then Appendix 35 accomplishes exactly that. The applicant's input is quoted below as a quick refresher of that input. Perhaps the PGCB should have considered redacting this portion of the application also. QUOTE Provide details of a compulsive or problem gambling plan. SC Gaming OpCo, LLC is committed to the promotion of responsible gaming among its employees, patrons and the public at large as a matter of its own social and business responsibility. The promotion of responsible gaming must include encouraging responsible risk taking by customers and increasing awareness among customers of tools that are available to combat problem gambling. In addition, SC Gaming OpCo, LLC will be committed to educating and training its employees to implement and enforce its responsible gaming policies and procedures. SC Gaming OpCo, LLC anticipates that its draft compulsive and problem gambling plan will be reviewed and further refined in advance of commencing operations by the property leadership that will be responsible for implementing it. UNQUOTE Here is what I consider to be a real-world translation of the above-listed plan: `We plan to clearly publish guidance and post signs wherever and whenever possible that refer problem gamblers to call 1-800-GAMBLER. That's it. That's where the problem gambler will be referred to contact Gamblers Anonymous (GA) so GA can then help the gambler with their compulsive or problem gambling disorder. Additionally, from our experience with this

topic, this is exactly the same plan every casino operator includes in their casino application process.` In summary, please do not approve the casino application for the proposed Category 4 casino in College Township. Approval of the application would definitely bring total chaos to Centre County. Sincerely, Daniel Materna Howard, Pennsylvania

Based upon the impact reports (being minimal) and projected revenue to the Township/County, I support this casino project. However, I believe that some of the up to 30 allowed table games should be set aside and put towards a poker room. A poker room would be a draw for the casino and local community as it would be the only one within a 1.5 hour drive of State College. It would bring people into the casino who would then play other table games and slots; not to mention spending money in the surrounding areas. The Pennsylvania Race Horse and Gaming Act states that table games are intended to supplement slot machine gaming by increasing revenue to the Commonwealth and providing new employment opportunities and skilled jobs. Creating a need for poker dealers would in fact create a `skilled job` (as anyone who has ever played poker from an unskilled dealer can attest to). While building a poker room and hiring dealers is in fact creating job opportunities, it would not necessarily decrease the bottom line. Poker dealers primarily make their money from tips or â€œtokensâ€ after a poker player wins a pot, which means while the casino is making rake, the dealers are earning their wage primarily from tips. Mandating that some of the 30 tables be used for poker would increase the tax money that passes to the County/Township, would help with compliance of the Pennsylvania Race Horse and Gaming Act by creating more `skilled jobs`,` and would create a draw to out of town and in town residents alike to come to State College and the Nittany Mall to spend some of their money into our local economy.
