### Pennsylvania Is Addicted to Gambling

Last Sunday's Super Bowl set a record with Americans wagering nearly \$8 billion on the game. This dramatic increase is a direct result of the legalization of sports betting; the matchup between the Rams and the Bengals was the <u>first Super Bowl of the online gambling era</u>.

Since online gambling and sports betting are now legal in Pennsylvania, Penn State has begun conducting <u>research on the prevalence and impacts of online gambling</u>. Key findings include that 11.1% of PA residents (i.e. about 1,400,000 million people) participated in online gambling and that 44.6% of PA residents who participated in online gambling (i.e. 4.95% of PA residents / about 643,000 people) exhibited at least one sign of gambling addiction.

Most research on gambling is funded by the gambling industry and is subject to conflicts of interest. Penn State's report is no exception – its background notes that "[t]he funding for this report is provided by law through the Pennsylvania Gaming Control Board [PGCB] from revenues of the interactive gaming licensees." The report unsurprisingly stops short of saying it is problematic for nearly 5% of the state's population to be addicted to online gambling, and it says nothing about the human or economic costs of gambling addiction on the individuals, families and communities that are affected.

Our government officials themselves are addicted to gambling because of the tax revenue that it generates — the report notes early on that online gambling "generated over \$372 million in direct gaming taxes" in Fiscal Year 2020-21. It does not detail that the owners of the online gambling sites keep a additional 85%-625% of the amount that they pay in taxes for themselves depending on the type of gambling that is taking place. Every dollar of that money is extracted from our state's economy and potentially redirected away from making productive economic investments or meeting citizens' immediate needs.

To make matters worse, our state leadership is aggressively pushing to increase the prevalence of gambling by opening more casinos. Just as an addict often needs increasingly frequent and powerful "hits" to experience the same rush that they felt at first, our leadership is approving more and more casinos despite the fact that they no longer provide the surge of tax revenue that is being sought. A 33% increase from 12 to 16 casinos during the past two years has increased overall Pennsylvania casino revenues by only 3.6%. Further increases in gambling tax revenues will only come by getting more citizens addicted to gambling.

The latest location being considered for a casino is our community's Nittany Mall. The casino industry is like a drug dealer and our citizens and elected officials are their users; the only way to stop this cycle of addiction before we hit rock bottom is for people who care about our community to stage an intervention. ### An Open Letter to Penn State President Eric Barron

Dear President Barron.

I am writing today to urge you to integrate college gambling education and prevention efforts into existing Penn State programs about alcohol, drugs and other risky behaviors.

Seventy-five percent of college students gambled during the past year (whether legally or illegally, on campus or off). While the vast majority of those old enough to legally gamble can do so responsibly, the most recent research estimates that 6% of college students in the U.S. have a serious gambling problem that can result in psychological difficulties, unmanageable debt and failing grades.

Higher education has responded vigorously to alcohol-related problems. Nearly all U.S. colleges and universities have policies on student alcohol use; however, only 22% have a formal policy on gambling. Those without policies in place have the responsibility to inform students about the risks of excessive gambling and to provide recovery-oriented measures. Now is the time for Penn State to meet that challenge and implement a formal policy on gambling.

Increased awareness of high rates of binge drinking has led to the development of numerous prevention programs. Working together, we can address gambling-related harms on and off campus, educate our college students on how to make responsible decisions about gambling and help those students struggling with gambling addiction.

I encourage you to visit <u>collegegambling.org</u>, which was developed by the National Center for Responsible Gaming and provides campus administrators and college health professionals with examples for promoting campus-wide awareness of college gambling.

Now is also the time for Penn State to speak out publicly as to whether Penn State University supports the approval or the denial of the casino license application for the proposed Nittany Mall casino in College Township. The township's website includes over four hundred public comments from area residents in Happy Valley. Each of them e-mailed that casino-related feedback to the Pennsylvania Gaming Control Board (PGCB) at boardclerk@pa.gov.

Penn State should do the same immediately by providing the PGCB with the university's position regarding the recommended approval or denial of the casino's license application. It is time to end the policy of silence Penn State has continually demonstrated regarding the proposed casino. Hundreds of our community members have expressed their opposition to the casino while emphasizing the potential negative impacts of a casino being available 24/7 near the main University Park campus of Penn State.

Thank you for your consideration of this important and growing issue. Your leadership in voicing Penn State's support of or opposition to the proposed casino at Nittany Mall would be greatly appreciated.

#### Will Penn State Leaders Speak Out About Casino?

Dear President Barron,

On February 18, 2020, you conducted an interview about sports gambling on WPSU. During this interview (quoted comments begin at 22:28), you stated the following:

"Students are very enthusiastic about sports, and very enthusiastic about Penn State sports. So you worry about whether or not a student might get in trouble, that the tuition dollar just got placed on a bet and they don't get to finish [their degree]. Hopefully it's not a common occurrence. But what I learned from the two individuals that I interviewed is the addiction rate in the normal population is about 1-2%. So there's sort of this sense that here's this big revenue

generator, and the problem part of it is 1-2% of the population. But they said in the college age population, the addiction rate is closer to 6%. So this suggests a certain amount of vulnerability with youth, or with the interest and the tie to our school or something like that, and so this is something to worry about I think."

Additionally, you previously asked the Pennsylvania Gaming Control Board (PGCB) to impose a two-year moratorium on sports betting because you were concerned that it would harm the integrity of college sports. According to The Morning Call, you stated that "Sources looking to influence or gain an unfair advantage in wagering on collegiate sporting events occurring in Pennsylvania will be overwhelmingly 'local' to Pennsylvania," and "The absence of financial compensation for amateur athletes creates an opportunity for inappropriate influence..."

However, now that former Penn State Trustee Ira Lubert is proposing to develop a casino with a sports book at the Nittany Mall, your office has gone strangely silent about the issues of sports betting and gambling addiction. Multiple people in our community have privately reached out to the Penn State Board of Trustees requesting that the university take a position on the casino, but every request has been rebuffed. Subsequently, multiple <u>open letters</u> have been published on this topic ( ).

Youth is not the only risk factor for gambling addiction; those who live within 10 miles of a casino have twice the rate of gambling addiction as those who do not. The proposed location of the new casino less than 5 miles away from Penn State's campus therefore makes this proposed casino an especially dangerous threat to our community. This is why nearly 40 letters to the editor have been published in opposition to the casino in the Centre Daily Times and on StateCollege.com since the beginning of 2021, and over 400 of the approximately 450 public comments submitted to the PGCB from our community oppose the casino.

Will you conclude your term as Penn State's president by speaking out to protect our community from the harms that a nearby land-based casino would bring? Or will you and the Penn State Board of Trustees abandon your responsibility to protect the Penn State community because this casino's developer is a former trustee?

### Dear President Barron,

I am writing in response to a recent open letter published on StateCollege.com urging you to speak out against the proposed casino at the Nittany Mall. I would like to add my voice as a new faculty member, educator, parent, and community member.

We moved to State College in summer 2020, lured by the university's commitment to research and education and because we saw Happy Valley as a quality community in which to raise our two school-age children. Last summer, my elderly mother joined us in order to have more support in this stage of her life, and she was likewise charmed by the pastoral setting, public safety, and community stability that we enjoy here.

In December, I was shocked to learn that the College Township board had approved an investor's proposal to take over part of the Nittany Mall to build a casino. As I noted at the time in my email to the PA Gaming Commission opposing this move, the mall houses a county-sponsored senior activity center (which my mother attends regularly to play games and socialize), and it also serves as an informal exercise track for families and individuals during the cold winter months. Placing a casino there would ruin the community functions of the mall and directly endanger those populations that regularly use it.

More broadly, a casino anywhere in State College and the surrounding hamlets would pose a significant and irreversible threat to our community's public health and social welfare. As I read the minutes of the College Township meetings where this proposal was discussed and approved, I was puzzled to see that there was no *substantive* engagement with the very real social costs that this casino would impose on the city and its residents. Instead, the questions posed were entirely banal, including what kind of landscaping would be provided, the size of the parking lot, and how large the entry overhang would be.

Why did the township officials not raise pertinent, evidence-based questions about the impact of the casino on our community? Surely a town that houses the flagship state university could harness the power of scholarly research to better understand the risks and challenges of bringing a casino into the community. Since the township did not do so, I urge you as the university president, with a tremendous responsibility not only to the students, staff, and faculty of Penn State and their families, but also to the surrounding community, to respond to the evidence and oppose this casino.

Although this is far from my field of expertise (I am a historian of the Middle East), I spent a couple of hours on my Saturday morning reviewing the scholarly literature on casinos and their economic and social costs to the communities in which they are built. The literature is very uneven in time, scope, and method, but the overall

assessment is clear and demands that we oppose this proposed casino for the short-, medium-, and long-term health of our community, our students, and our collective future.

The five main points are bolded, with relevant quotes and citations following.

### 1 - The Economic Benefits are Minimal to Nonexistent

While casinos are lucrative investments for the owners [due to the laws of probability, i.e., the house always wins], the wider economic benefits that are promised have not materialized in communities across the country. (There are possibly greater economic benefits in regions that allow multiple casinos to enter or in casino resorts due to scale and market size, but *not* in single-casino locations.)

"During the campaigning stage of the legalization of gaming, tourism development and economic growth were used as the "hook" for residents' affirmative votes. As indicated by Hsu (1998), the economic impact of a riverboat casino in southeastern lowa was limited. Economic indexes showed that the economic conditions of those communities seemed to be a reflection of the overall state economy, not the presence of the riverboat casino."

# 2 - The Socioeconomic Costs Far Outweigh Any Benefits

There is a clear assessment that the social welfare, public health, and community-born costs of operating a casino are far higher than the minimal economic benefit they bring. Notably, these costs are *not* born by the casino investors nor by the casino customers, but by all of us.

"Based on available numbers, costs [of allowing casinos] exceed benefits by a factor of more than 3:1." This includes the social costs of crime, business and employment costs, suicide, illness, social service costs, direct regulatory costs, family costs, and abused dollars.

3 – Specific Social Problems [Crime, Bankruptcy, Suicide, Compulsive/Pathological Gambling] Increase with Casinos

There is empirical correlation of statistically significant higher levels of a number of specific social problems in casino locales – most notably, crime, bankruptcy, suicide, and mental health gambling issues that contribute to additional ills such as domestic abuse. These are not community "fears" or "anecdotal evidence," but widespread and documented problems.

"The results suggest that the effect on crime is low shortly after a casino opens, and grows over time. Roughly 8% of crime in casino counties in 1996 was attributable to casinos, costing the average adult \$75 per year."

### 4 - Seniors and Low-Income Households are at risk

The consensus of the scholarship is that gambling disproportionately attracts lower-income populations including seniors on fixed incomes. Likewise, gambling problems disproportionately affect these classes.

"The most dramatic increase in lifetime gambling occurred in the 65+ age group, from 35% of older adults to 80%. lower-income households spend proportionately more of their money on gambling than higher-income households. Given that some gambling revenue goes to the government (e.g., lotteries), these data encourage the view that gambling expenditures represent a regressive tax. Poverty often is associated with increased financial risk-taking, perhaps because of the psychoeconomics of gambling."

### 5 - Teens and College Students are Particularly Vulnerable

It is no wonder that the investors would like to place their casino near Penn State University, as studies of gambling on other college campuses have found that the vast majority of students have gambled, with significant numbers of them gambling on a regular basis.

Moreover, there are a number of recent studies on teens and college students and the "epidemic" of gambling that outline the clear danger to individual students and to the student body as a whole. Habitual gambling among teens leads to a number of social problems, including alcohol and drug abuse, negative learning outcomes, eating disorders, and more.

"Students from six colleges and universities in five states in the U.S. (New York, New Jersey, Oklahoma, Texas, and Nevada) were surveyed concerning their gambling behavior and the rate of pathological gambling. Type of gambling varied by state, with students in the northeast and Nevada gambling more than students in Oklahoma and Texas. Over 90% of males and 82% of females had gambled. One third of the males and 15% of females gambled once a week or more."
