# PGCB Reports Total Pennsylvania Gaming and Fantasy Contest Revenue for Calendar Year 2020

**HARRISBURG, PA:** Even with strong revenue increases from newer gambling initiatives such as sports wagering and iGaming, closures of retail gaming due to the Covid-19 pandemic led to 22.24% drop in gaming revenues in 2020, according to the Pennsylvania Gaming Control Board.

Casino closure days totaled 1,473 in 2020, or 33% of the number of days the 13 casinos would have been operating in a normal year. Additionally, VGT establishments were shut down for a similar percentage of days due to Covid-19 safety measures.

For the year, the combined revenue of slot machine, table games, sports wagering, iGaming, video gaming terminals (VGTs) and fantasy contests totaled \$2,653,511,029 compared to \$3,412,594,239 in 2019.

At the same time, the combined revenue of the four other forms of gaming established under the Gaming Expansion Act of 2017 and regulated by the Gaming Control Board took in \$793,276,978, an increase of 443.66% over revenue of \$145,914,380 achieved for those games in 2019.

Estimated combined tax revenue from these gambling initiatives for 2020 was \$1,098,970,241 compared to \$1,415,879,539 in 2019. Tax revenue figures reflect amounts generated prior to any adjustments by the PA Department of Revenue.

#### **Slot Machine Revenue**

Gross revenue from slot machines at the casinos was \$1,355,924,785, a 42.62% decrease in revenue when compared to the \$2,363,085,678 generated in 2019.

## **Table Games Revenue**

2020 gross revenue from table games at the casinos was \$504,309,266, a 44.19% decrease in revenue when compared to the \$903,594,181 generated in 2019.

## **Sports Wagering Revenue**

2020 revenue from sports wagering was \$189,703,465, a 126% increase in revenue when compared to the \$84,112,967 generated in 2019.

## Fantasy Contests Revenue

2020 revenue from fantasy contests was \$21,148,707, a 18.26% decrease in revenue when compared to the \$25,872,124 generated in 2019.

#### iGaming Revenue

2020 revenue for iGaming was \$565,776,908 an 1583.87% increase in revenue when compared to the \$33,599,749 generated in 2019. The first iGaming provider became operational in July 2019. At the end of 2020 there were 10 iGaming certificate holders operating 13 online sites in Pennsylvania.

## Video Gaming Terminals (VGTs)

2020 revenue for VGTs at Truck Stops was \$16,647,898 a 615% increase in revenue when compared to the \$2,329,540 generated in 2019. The first VGT's became operational in August 2019. At the end of the year there were 40 VGT facilities in Pennsylvania.

#### **About the Pennsylvania Gaming Control Board**

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling legalized under 2004's Race Horse Development and Gaming Act and the Gaming Expansion Act of 2017. In addition to slot machine and table games gambling at 13 land-based casinos, the expansion includes online casino games available to date on 13 sites; sports wagering offered through sportsbooks at 14 retail locations and through 12 online outlets; Video Gaming Terminals (VGTs) offered as of this date at 41 qualified truck stops; and, fantasy sports contests through eight providers.

The land-based casino industry in Pennsylvania currently consists of six racetrack (Category 1) and four stand-alone (Category 2) casinos in, along with the two resort (Category 3) casinos

and one mini-casino (Category 4). These facilities collectively employ over 16,000 people and, along with other types of Board-regulated gaming, annually generate over \$1.5 billion in tax revenue. An additional Category 2 casino, Live! Casino Philadelphia, plans to open this month, while a number of Category 4 casinos are expected to begin operation over the next couple of years.
