## Gaming Control Board Reports Gaming Revenue for February

*Sports wagering revenue shows loss in February during an overall 24% gaming rise*

**HARRISBURG, PA:** The Pennsylvania Gaming Control Board reported today that the combined total revenue generated from all forms of gaming along with fantasy contests during February 2022 was \$375,678,415 an increase of 24.41% compared to revenue generated in February 2021.

Sources of gaming revenue regulated by the Pennsylvania Gaming Control Board include slot machines, table games, internet gaming, sports wagering, fantasy contests and VGTs. The Board has posted separate reports for these types of gaming on its website, <https://gamingcontrolboard.pa.gov/>.

The following chart compiles all revenue generated in February 2022 by casinos along with fantasy contests and video gaming terminals operated by other vendors and includes a comparison to total revenue generated last February.

### **Slot Machine Revenue**

February's gross revenue from slot machines was \$194,692,492, a 33.49% increase in revenue when compared to the \$145,851,166 generated in February 2021.

The number of slot machines in operation in February 2022 was 26,154 compared to 26,358 at the casinos in February 2021.

Table games revenue for February 2022 was \$74,372,715, an increase of 29.57% from February 2021 when revenue was \$57,399,564.

Casino games offered online generated gross revenue of \$102,419,293 during February 2022 compared to \$77,788,457 in February 2021 an increase of 31.66%.

### Sports Wagering Revenue

February 2022 total sports wagering handle was \$597,064,049 or 17.18% above the February 2021 total of \$509,547,820. At the same time, the taxable revenue figure for February 2022 was -\$442,847 compared to \$16,379,807 in February 2021.

### **Video Gaming Terminals**

Total adjusted revenue for February 2022 for video gaming terminals (VGTs) was \$3,031,625 or 20.47% higher than February 2021 when revenue was \$2,516,556. By the close of February 2022, four VGT Terminal Operators were operating the maximum permitted five machines at 61 truck stop establishments.

### **Fantasy Contests**

Fantasy Contests revenue was \$1,605,137 in February 2022, a decrease of -21.48% over February 2021, when revenue was \$2,044,270.

### **About the Pennsylvania Gaming Control Board**

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling involving 16 land-based casinos, online casino games, retail and online sports wagering, and Video Gaming Terminals (VGTs) at qualified truck stops, along with the regulation of online fantasy sports contests.

The land-based casino industry in Pennsylvania consists of six racetrack (Category 1) casinos, five stand-alone (Category 2) casinos, two resort (Category 3) casinos and three mini-casinos (Category 4). Casino expansion will continue over the next couple of years with the anticipated openings of up to two additional Category 4 casinos. A significant job generator in the Commonwealth, casinos and the other types of Board-regulated gaming is expected to generate over \$2 billion in tax revenue during the 2021/2022 State Fiscal Year.
