### Gaming Control Board Reports Total Gaming Revenue for August

**HARRISBURG, PA:** Figures released today by the Pennsylvania Gaming Control Board show total gaming and fantasy contests revenue generated in the Commonwealth during August 2020 was \$310,717,728 which represents an increase of almost 6% over revenue generated in August 2019 of \$293,434,087.

Sources of gaming revenue regulated by the Pennsylvania Gaming Control Board include slot machines, table games, internet gaming, retail and internet sports wagering, fantasy contests and video gaming terminals (VGTs). The following chart compiles all revenue generated in August 2020 by casinos along with fantasy contests and video gaming terminals operated by other vendors, and includes a comparison to total revenue generated last August:

### **Slot Machine Revenue**

August's gross revenue from slot machines at the casinos was \$166,999,047, a 19% decrease in revenue when compared to the \$206,260,869 generated in August 2019.

The number of slot machines in operation on August 30, 2020 was 16,008 compared to an average of 24,451 at the casinos in August 2019.

Tax revenue from the play of slots machines in August of this year was \$86,265,164\*.

### **Table Games Revenue**

Table games revenue for August 2020 was \$65,119,689, a decrease of 14.5% over August of last year when revenue was \$76,184,709.

### **Internet Casino-Type Gaming Revenue**

Casino games offered online generated gross revenue of \$55,942,525 during August 2020 compared to August 2019 when revenue was only \$3,428,640. The August 2020 figure eclipses the previous revenue high achieved in May of this year.

### **Sports Wagering Revenue**

August 2020 total sports wagering handle was \$364,985,423, or 122% higher than July 2020 total of \$164,782,229. It was also the highest monthly handle to date topping January 2020's handle of 348,381,708.

The taxable sports wagering revenue figure for August 2020 was \$18,387,277 or 126% higher than July 2020 taxable revenue of \$8,147,480.

### **Video Gaming Terminals**

Total adjusted revenue for August for video gaming terminals (VGTs) was \$2,247,898. By the close of August four VGT Terminal Operators were operating five machines at each of 36 truck stop establishments.

Tax revenue collected from the play of VGTs in August was \$1,168,907\*.

### **Fantasy Contests**

Fantasy Contests revenue was \$2,134,494 in August 2020, a increase of 54% over August of last year when revenue was \$1,388,631.

### **About the Pennsylvania Gaming Control Board**

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling legalized under 2004's Race Horse Development and Gaming Act and the Gaming Expansion Act of

2017. In addition to slot machine and table games gambling at land-based casinos, the expansion includes online casino games available to date on 12 sites; sports wagering offered through sportsbooks at 12 retail locations and through nine online outlets; video gaming terminals (VGTs) offered as of this date at 36 qualified truck stops; and, fantasy sports contests through six providers.

The mature land-based casino industry in Pennsylvania currently consists of 10 stand-alone and racetrack casinos in operation, along with the two smaller resort casinos. These facilities collectively employ over 16,000 people and, along with other types of Board-regulated gaming, annually generate over \$1.5 billion in tax revenue. Construction of a 13th casino is currently underway along with a number of new “mini-casinos” expected to begin operation over the next couple of years.
