Gaming Control Board Reports a 2.7% revenue increase in January 2024 compared to January 2023

HARRISBURG, PA: The Pennsylvania Gaming Control Board (PGCB) reported today that the combined total revenue generated from all forms of gaming, along with fantasy contests, during January 2024 was \$477,151,563, an increase of 2.72% compared to revenue generated in January 2023.

Sources of gaming revenue regulated by the PGCB include slot machines, table games, internet gaming, sports wagering, fantasy contests and video gaming terminals (VGTs). The PGCB has posted separate reports for these types of gaming on its website, <https://gamingcontrolboard.pa.gov/>.

Total tax revenue generated collectively through all forms of gaming and fantasy contests was \$195,226,186* during January 2024.

The following chart compiles all revenue generated in January 2024 by casinos, along with fantasy contests and VGTs operated by other vendors and includes a comparison to total revenue generated in January 2023.

Slot Machine Revenue

January's revenue from slot machines was \$179,507,293, a 11.42% decrease in revenue when compared to the \$202,240,506 generated in January 2023.

The number of slot machines in operation in January 2024 was 24,949 compared to 25,799 at the casinos in January 2023.

Retail Table games revenue for January 2024 was \$72,658,060, a decrease of 13.41% from January 2023 when revenue was \$83,912,666.

Casino games offered online generated monthly gross revenue totaling \$149,563,721 during January 2024 compared to \$133,119,361 in January 2023, an increase of 12.35%.

Sports Wagering Revenue

January 2024, total sports wagering handle was \$858,152,503 or 11.12% above the January 2023 total of \$772,289,648.

At the same time, the taxable revenue figure for January 2024 was \$69,924,036, or 78.15% higher when compared to January 2023, when taxable revenue was \$39,250,402.

Tax revenue generated from sports wagering during January 2024 was \$25,172,653*.

Video Gaming Terminals

Total adjusted revenue for January 2024 for video gaming terminals (VGTs) was \$3,039,145, or 9.21% lower than January 2023 when revenue was \$3,347,366. By the end of January 2024, all VGT Operators offered the maximum permitted five machines at 72 qualified truck stop establishments, compared to five machines at 66 establishments at this time last year.

About the Pennsylvania Gaming Control Board

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling involving 17 land-based casinos, online casino games, retail and online sports wagering, and Video Gaming Terminals (VGTs) at qualified truck stops, along with the regulation of online fantasy sports contests.

The land-based casino industry in Pennsylvania consists of six racetrack (Category 1) casinos, five stand-alone (Category 2) casinos, two resort (Category 3) casinos and four mini-casinos (Category 4). A significant job generator in the Commonwealth, casinos and the other types of Board-regulated gaming generated \$2.35 billion in tax revenue during in 2023.
