Chair Smyler announced that the Board held an Executive Session on April 23<sup>rd</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on April 24<sup>th</sup>.

**MINUTES/TRANSCRIPT**

On a motion by Commissioner Regan, seconded by Commissioner Dillon, the Board unanimously approved the minutes and transcripts of the February 21, 2024, meeting.

**EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Kevin O'Toole, began his report by recognizing and expressing his and the seven Gaming Control Board members' appreciation for the Board's 14 Administrative Professionals, for Administrative Professionals Day. He stated these employees have contributed in many significant ways to the success of the PA Gaming Control Board, and eight of them have 10 to 15 years of service, while the others are on their way to that plateau. Kevin concluded his report by thanking the following individuals for their service and unwavering commitment to the important work they perform day after day to ensure the Board accomplishes its goals and objectives to fairly and competently regulate the casino industry and all gambling expansion activities: Kathleen Black, Jaclyn Bruce, Deborah Davis, Sarah Heisey, Alexa Knisely, Shaun Kovach, Sarah Marley, Tara Ottenberg, Deena Pietsch, Cheryl Posavec, Stacey Russell, Linda Schramm, Kelly Spittle and Angela Yanoscak.

**OFFICE OF FINANCIAL MANAGEMENT**

Director of Budget, David Rhen, provided an update of Board Expenditures through the end of the 2023-2024 Fiscal Year's Third Quarter, which was March 31, 2024. Dave explained through the third quarter, the Board expenditures totaled \$37,584,000 or 72% of the total appropriation of \$52,159,000 which are in line with expectations. He further stated expenditures were up \$3.8 million from the same date last fiscal year, due to the expansion of the agency complement, general salary, and benefit cost increases. Mr. Rhen also explained 91% or \$34,120,000 of board expenditures to date had been for payroll, which he explained included 20 million for salaries and \$13.9 million for benefits. Dave stated benefits were 69% of salary costs and for the year, payroll expenses went up \$3.8 million. He concluded his budget report by explaining operating expenses totaled \$3.5 million, which is up \$45,000 from last year. He explained the largest operating expenses were \$1.3 million, or 38% of total operating expenses for rental and leases, \$1 million for services (predominantly IT consultants and interagency billings for services provided by other state agencies to the Board), and \$688,000 for other operating expenses, which Dave stated included fingerprint and database fees related to background investigations.
