A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on May 21st to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on May 22nd.

Chair Smyler also announced the retirement of the Director of Human Resources, Danette Bixler-George. She then continued to thank her for her 30 years of state service, 6 of which were at the PGCB, and congratulated her on her retirement.

MINUTES/TRANSCRIPT

On a motion by Commissioner Ralston, seconded by Commissioner Hickernell, the Board unanimously approved the minutes and transcripts of the March 20, 2024, meeting.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole began his Executive Director's report by commenting on the measurements of success for the licensed and regulated gaming industry in the Commonwealth of Pennsylvania, by using the first measurement tool for commercial success, being Revenue.

Kevin continued his report by mentioning the American Gaming Association, or AGA, issued a report that stated the First Quarter of 2024 commercial gaming revenue nationwide set a new quarterly high, which marked 13 straight months of casino industry growth. He also stated Pennsylvania's First Quarter revenue from all sources regulated by the PA Gaming Control Board totaled \$1.53 billion, which was an increase of 6.56% over the gaming revenue for the First Quarter of 2023.

Mr. O'Toole also stated the Board's Communications Department reported that the month of April continued the positive revenue, by increasing 5.87% that month. He further mentioned revenue from all sources totaled over \$504 million dollars in April.

Kevin also noted that online gaming activity for slots, tables and sports wagering have experienced the largest percentage of revenue increases. He also noted the land-based casinos maintained their revenue figures but did not experience any increase more than a few percentage points. Kevin also explained it was also important to measure success from a non-revenue context. He explained when the PA Race Horse Development and Gaming Act was enacted into law, and when it was amended, the Legislature always established goals which focused on non-revenue components of licensed and regulated gaming. Kevin continued to explain those goals included making sure jobs were created and available to Pennsylvanians, that economic development continued to prosper, and the horse racing industry would continue to be an important part of the Agriculture within the Commonwealth. Mr. O'Toole also explained the 17 brick and mortar casinos employ over 15,000 employees. He clarified the category 1 and category 2 casinos average approximately 1,100 employees per facility, while the category 3 and 4 casinos average almost 600 employees per facility.

Kevin further stated that, from an economic development perspective, the brick-and-mortar casinos continue to strive to maintain some of the best casino properties in the country, with 8 casino facilities in Pennsylvania currently offering hotels as part of its amenities. Additionally, Kevin stated there were 16 casino locations that significantly modified their gaming floor to provide a first-class retail Sportsbook for its patrons who engaged in legal sports betting. He also mentioned it is important to remember that the six category 1 casinos continue to operate horse racing tracks that continue to add to the overall entertainment and wagering opportunities for its patrons.

Mr. O'Toole concluded his report by stating that increasing revenue was a goal that Pennsylvania casinos and online operators seek to achieve under much competitive pressure, and apart from revenue, the Pennsylvania casinos have been successful in their efforts to meet non-revenue related goals and expectations.
