A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on June 25th to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on June 26th.

Chair Smyler also announced the Board had scheduled a Public Input Hearing, related to the license renewal application of Wind Creek Bethlehem. The hearing will be held Thursday, June 27th, beginning at 10:30 am, at the Bethlehem Town Hall, located at 10 East Church Street, Bethlehem, Pennsylvania 18018.

MINUTES/TRANSCRIPT

On a motion by Commissioner Regan, seconded by Commissioner Dillon, the Board unanimously approved the minutes and transcripts of the April 24, 2024, meeting.

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole began his Executive Director's report by making a few comments about recent gaming revenue figures, which were published by the PA Gaming Control Board's ("PGCB") Office of Communications.

He stated for the month of May 2024, PGCB's total gaming revenue from all sources they regulate equaled approximately \$521,000.00 and since the beginning of this year, monthly revenue had exceeded \$500 million on three separate occasions, with this past May's total being the second highest amount of gross gaming revenue this year, only behind the month of March 2024, which boasted a total revenue of approximately \$554 million.

Kevin went on to explain further that gaming revenue for May 2024, was 8.68% greater than the previous year's May revenue, which was due primarily to online gaming activity. He stated online slots rose 26.15%, online table games rose 18.58% and online sports betting rose 7.56% respectively when compared to figures from May 2023. Kevin also spoke about land-based casino's revenues for slots and table games reached almost \$298 million, and their percentage increase from 2023 were 1.55% for slot machines and 2.54% for table games.

Mr. O'Toole also mentioned that despite the differences in growth rates between online casino operations and land-based casino operations, the casino facilities have been positioning themselves well with their full-service entertainment areas, convention, and event spaces, and having the newest slot machines and table games available for their patrons.

Kevin concluded his report with a final point regarding the fact that Legislature, after approving the 2017 gambling expansion bill, required an equal percentage of online slot machine gaming taxes which is the same as required from the land-based slot machines gaming taxes, which will go to the Property Tax Relief Fund.
