## **ANNOUNCEMENTS**

Chair Smyler announced that the Board held an Executive Session on November 19<sup>th</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on November 20<sup>th</sup>.

## **EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Kevin O'Toole, began his Executive Director's report by announcing PGCB's Office of Communications will be releasing their Press Release, which will report the October revenue from all forms of Board regulated gaming. Kevin further announced the total combined revenue for October of 2024 was \$496,585,461 which is an increase of 2.18% in comparison to October of 2023. He also stated the total tax revenue generated collectively, through all forms of gaming during October of 2024, was \$209,157,522.

Mr. O'Toole also discussed three important notes regarding the October revenue report, the first being a continued strong month in the area of Land-Based slot machine revenue, with a total of \$200,625,182. The second item of importance discussed was the 28.26% revenue increase in the area of Online slots, in comparison to the previous year. Online slots total revenue for October of 2024 is \$140 million and the highest monthly online slots total to date. Kevin concluded his report with his third takeaway regarding the VGT revenue at licensed VGT Truck Stops in Pennsylvania continue to show strong revenue figures with a total of \$3,556,562 in October of 2024, a 4.42% increase from October of 2023.

Executive Director O'Toole also acknowledged Chair Smyler on her 2024 recognition by Tribute Magazine as one of the Most Influential African Americans of Philadelphia.

## PUBLIC COMMENT

Josh Ercole, representing the Council on Compulsive Gambling of Pennsylvania, who is the state affiliate of the National Council on Problem Gambling, expressed his concerns to the proposed changes to PA's Self-Exclusion list, which will have people automatically taken off the self-exclusion list after their excluded time is up, rather than the current process. He explains himself, along with several colleagues believe this change would reduce the overall effectiveness of the program and he encourages the Board to review the National Council on Problem Gambling's internet responsible gambling standards, in which active removal from the program is recommended to best protect players. Additionally, Josh added that people already on the excluded program will still have to do the extra steps to be taken off, while people put on the self-exclusion list after this proposal will not have to, resulting in more confusion. He stated this proposal also leaves room for other issues such as gambling disorder and relapse, customer choice and best practices in gambling.
