A quorum of the Board being present, Chair Smyler called the meeting to order.

#### **ANNOUNCEMENTS**

Chair Smyler announced that the Board held an Executive Session on January 28<sup>th</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on January 29<sup>th</sup>.

#### MINUTES/TRANSCRIPT

On a motion by Commissioner Ralston, seconded by Commissioner Hickernell, the Board unanimously approved the minutes and transcripts of the October 23, 2024, meeting.

On a motion by Commissioner Hickernell, seconded by Commissioner Dillon, the Board unanimously approved the minutes and transcripts of the November 20, 2024, meeting.

## **EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Kevin O'Toole, began his Executive Director's report by sharing key data regarding gaming revenue produced by the Pennsylvania gaming industry in calendar year 2024. He started by discussing one of two recently issued Press Releases, from PGCB's Office of Communications, which summarized revenue for the month of December 2024, while the other provided information regarding the entire calendar year of 2024.

Kevin stated gaming revenue for the month of December 2024 reached \$533 million in taxable revenue, which helped to propel the 2024 calendar year revenue overall, from all sources of gaming activity that falls under the regulatory oversight of the Gaming Control Board, to \$6.1 billion. Kevin further stated the \$6.1 billion is a 7.73% increase over the combined gaming revenue of \$5.7 billion in calendar year of 2023, which resulted in gaming tax revenue for 2024 to be \$2.66 billion, an 8.53% increase over the \$2.45 billion gaming tax revenue generated in 2023.

Mr. O'Toole also explained the breakdown of the \$6.1 billion total revenue figure which included land-based casinos generating \$3.38 billion in gaming revenue from the play of slot machines, table games and poker, which represents a 1.5% decrease when compared to 2023. Kevin further explained online casino games, online table games and online poker revenues for 2024 amounted to almost \$2.2 billion, which was a 25% increase over the \$1.7 billion produced in 2023 while the sports wagering revenue for calendar year

2024 was \$510 million, an 11.36% increase over the previous calendar year.

Kevin stated the aforementioned figures depicted that online casino gaming, still in its first 6 years, continues to grow at a significant rate, while sports wagering also continues to gain more and more followers as evidenced by a significantly greater revenue, totaling \$8.4 billion the past year, a 9.62% increase over the previous year. Kevin expressed Pennsylvanians continue to show licensed and regulated gambling is an activity that they enjoy participating in and as the next year comes, the PGCB and its staff will continue to do its part to ensure that tested and approved games, whether in a retail casino or online, are intended to protect the public and ensure fairness in all aspects of gaming activity.

Mr. O'Toole followed up by stating that while gaming taxes are very important, the Local Share Assessments ("LSA"), which the Casino Industry funds, are equally important. He stated public notifications were made by a number of counties that LSA funds were being disbursed to local municipalities, and were aimed at improving infrastructure, public safety, and community health. Kevin concluded his report by explaining these assessments and disbursements, made on a local and county wide basis, benefit so many communities in the Commonwealth and make the gaming industry so important to so many people.

#### **OFFICE OF FINANCIAL MANAGEMENT**

Dave Rhen, Director of Financial Management, gave his report on expenditures for the first half of the fiscal year through December 31<sup>st</sup>. He reported the board expenses for the first half of the fiscal year were \$25,676,347 and were made up of personnel expenses in the amount of \$22,527,371 along with \$3,148,977 in operating expenses. Dave explained compared to the prior year, personnel expenses increased by \$1,272,799 while operating expenses increased by \$1,197,174.

Mr. Rhen also explained that total payroll costs amounted to \$22,527,371, which included Salary Costs of \$13,346,237 and Benefit Costs of \$9,181,133. Dave further explained that the increase in personnel expenses was primarily attributed to an increased employee count, union-negotiated raises, and benefit cost increases. He also stated operating expenses through December totaled \$3,148,977 with the largest operating costs including IT consulting expenses and interagency billing services totaling \$1,355,849, and rentals and leases expenses totaling \$747,219. Mr. Rhen also stated \$746,022 was spent on other operating expenses including database services for background investigations.

Dave Rhen explained the growth in operating expenses reflects increased investments in technology modernization to support organizational operations, and timing difference in payments for Directors Insurance and the Office of Administration's IT Shared Services interagency billing. He ended his report by stating the expenditure trends for the first half of the fiscal year indicate alignment with projected growth in personnel and operational needs.
