A quorum of the Board being present, Chair Smyler called the meeting to order.

#### **ANNOUNCEMENTS**

Chair Smyler announced that the Board held an Executive Session on March 25<sup>th</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on March 26<sup>th</sup>.

Chair Smyler also announced that the Board has scheduled two Public Input Hearings relative to the license renewal applications for Penn National Morgantown and Parx Casino. Penn National Morgantown's hearing will be held on Wednesday, April 2<sup>nd</sup>, beginning at 1:30 PM, at the Caernarvon Township Building, located at 3307 Main Street, Morgantown, Pennsylvania 19543. Parx Casino's hearing will be held on Thursday, April 3<sup>rd</sup>, beginning at 10:30 AM, at the Bensalem Township Municipal Building, located at 2400 Byberry Road, Bensalem, Pennsylvania 19202. She also stated that the public is invited to attend both hearings and provide testimony.

Chair Smyler finished her announcements by recognizing the service of Commissioner David Hickernell to the Board since his term has expired and this will be his last public meeting.

On a motion by Commissioner Regan, seconded by Commissioner Dermody, the Board unanimously approved the minutes and transcripts of the January 29, 2025, meeting.

#### **EXECUTIVE DIRECTOR'S REPORT**

Executive Director Kevin O'Toole started his report by stating that March is Problem Gambling Awareness Month and that the Gaming Control Board recently issued a Resolution recognizing the significance of problem gambling and the need to highlight resources that support prevention, education, treatment and recovery. He stated that key personnel with our Office of Compulsive and Problem Gambling attended 2 conferences presented by the Council on Compulsive Gambling of PA and our Director of the Office of Compulsive and Problem Gambling, Liz Lanza, testified on Monday before the House Gaming Oversight Committee. Liz did a great job of presenting Gaming Regulation's role in regard to addressing issues related to compulsive and problem gaming.

Kevin also took this opportunity to update the Board on the topic of self-imposed limits ("SILs"), a topic that he presented in October of last year. He stated that the Gaming Control Board regulations at Section 814 offer bettors a number of responsible gaming SILs. These limits allow a gambler to control the amount of their deposits to their online gaming accounts. It also allows the online player the ability to set a maximum amount per wager, to set a maximum amount of funds the player wants to spend during their online gaming session, and if necessary, the player can activate for themselves a cooling off period during which their online wagering account is deactivated from play. One requirement exists for the cooling off period – that requirement is that it must be imposed for a minimum of 72 hours – a 3-day period. Kevin continued by saying how Board staff have been able to monitor the use of these SILs on a monthly basis through the assistance of online gaming operators who provide the statistics for their registered player accounts. The most used limit is the deposit limit, and the second most used limit is the self-suspension or cool-down period.

Kevin stated that the statistics show a significant increase in the use of those two player SILs between the months of August 2024 and February 2025. In August 2024, deposit limits were activated over 193,000 times. In February 2025 activations of deposit limits increased to over 285,000 times. Similarly, the self-suspension cool-down periods were used over 105,000 times in August 2024 and that increased to 141,000 times in February 2025.

He also stated one additional statistic is very probative in the discussion of SILs, that being the percentage of PA online accounts that used SILs to help control their gambling activity. The utilization rate for SIL's increased from 4% of PA online account holders to 4.43% of PA online account holders during the same period analyzed.

Lastly, Kevin stated that our Office of Communications has added a new employee, Kristina Kwolek, to enhance and modernize important messages from the Gaming Control Board to a broader audience. Such topics will include problem gambling, and how the Gaming Control Board's regulations protect the gaming public. The messages will provide a fresh look and will be communicated through social media channels. Kevin concluded by stating how we are excited about this effort to provide the public with a deeper understanding about the work we do and bring new information to them about legalized gambling in the Commonwealth.
