A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on April 22nd to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on April 23rd.

Chair Smyler also announced our newest Board Member, George Dunbar. George was appointed by the House of Representatives Republican Leader, Jesse Topper, and was sworn in on April 1st.

MINUTES/TRANSCRIPT

On a motion by Commissioner Manzano-Díaz, seconded by Commissioner Ralston, the Board unanimously approved the minutes and transcripts of the February 26, 2025, meeting.

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole, started his report by stating that the Board's Office of Communications issued its Press Release on Monday, April 21st, which reported the combined total revenue generated during March 2025 from all forms of gaming along with fantasy contests.

Kevin stated that March has traditionally been a very good month for revenue growth and this past month was no exception. March 2025 generated \$574,534,000 in aggregated revenue, an increase of 3.59% over aggregate revenue of \$554,625,000 in March 2024. He highlighted the report for March 2025 was a significant year in iGaming revenue, which was more than \$47 million higher than the revenue generated in March 2024, representing an increase of 24.67%.

Kevin proceeded to talk about the area that showed a decline in March year over year was Sports Wagering revenue. He stated that the revenue for Sports Wagering in March 2025 was \$27,026,000, a 40% decline from Sports Wagering revenue in March 2024. However, it appeared that Patrons did well during March madness.

Executive Director O'Toole stated that the total gaming taxes paid to the Commonwealth from all forms of Gaming during March 2025 was \$244,334,000, which represents a 6.43% increase over 2024's Tax revenue generated of \$229,567,000.

Kevin began to state that March 2025 overall showed a positive growth in revenue when all sources of revenue were aggregated. He finished by stating that the First Quarter of 2025 also shows an increase of approximately \$50,000,000 over the First Quarter of 2024, which represents a 3.27% increase.

OFFICE OF FINANCIAL MANAGEMENT

Director of Financial Management, David Rhen, started his report with an update of Board expenditures through the end of the third quarter, which was March 31.

He continued to state that through the third quarter, Board expenditures totaled \$40,382,771 against an appropriation of \$57,222,000, with the total expenses being in line with expectations.

Dave continued by stating that expenditures are up \$2.8 million from the same date last fiscal year due to the expansion of the agency complement and IT modernization costs, with 89% of costs or \$35.8 million to date for payroll. This includes \$20.9 million for salaries and \$14.9M for benefits, with benefits being 69% of salary costs, and for the year, payroll expenses are up \$1.6M.

Dave concluded his report by stating that operating expenses totaled \$4.6 million, which is up \$1.2 million from last year. The largest operating expenses being \$2.1 million or 46% of total operating expenses for services (predominately for IT modernization and interagency billings for services provided by other state agencies to the Board), \$1.2 million for rentals and leases, and \$911,000 for other operating expenses, which includes fingerprint and database fees related to background investigations.
