A quorum of the Board being present, Chair Smyler called the meeting to order.

**ANNOUNCEMENTS**

Chair Smyler announced that the Board held an Executive Session on June 24<sup>th</sup> to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on June 25<sup>th</sup>.

Chair Smyler finished her announcements by recognizing the service of Commissioner Frances J. Regan to the Board since her term has expired and this may be her last public meeting.

**BOARD RESOLUTION****PGCB MOTION NO. 2025-04 EXE**

On a motion by Commissioner Dermody, seconded by Commissioner Dillon, the Board unanimously approved a resolution commemorating the service of Commissioner Fran Regan to the Board.

**MINUTES/TRANSCRIPT**

On a motion by Commissioner Dillon, seconded by Commissioner Dunbar, the Board unanimously approved the minutes and transcripts of the April 23, 2025, meeting.

**EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Kevin O'Toole, started his report by stating that the Board's Office of Communications issued its Press Release last week to report the combined total gaming revenue generated during May 2025 from all forms of gaming under the regulatory oversight of the Pennsylvania Gaming Control Board.

He stated that May 2025 turned out to be a very significant month, generating over \$601 million in aggregated revenue, which is an increase of 15.5 % over May 2024's aggregated revenue and is the highest monthly total of gaming revenue to date. Kevin continued by saying that the total tax from gaming revenue during May 2025 exceeded \$255 million dollars and that significant increases year over year occurred again in the online gaming categories with iGaming slots increasing revenue of almost 40%, iGaming Sports Wagering increasing revenue of almost 35%, and iGaming Poker increasing revenue of almost 21%.

Kevin also stated that if you follow gaming revenue trends, most likely you look closely at the land-based casino revenue to measure the effect of online gaming activity on the traditional slot machine and table game revenue and there is an effect month in and month out. However, through the efforts of

Pennsylvania land-based casino operations, retail slots and retail table games combined revenue increased in May, year over year, by 2.33%. He said that it is important to note that retail slot machine revenue in May 2025 of \$225 million led all categories of gaming including the online gaming categories.

Kevin ended his report by emphasizing that licensed and regulated “PA Gaming” means something special to operators, to regulators, and to affiliated entities. As the Board continues to attend public input hearings near the land-based casino facilities as part of the license renewal process, we listen to presentations by casino executives and public entity representatives, which focuses on the outstanding physical facilities at these casino locations, the loyal player base at each casino location, and the consistent commitment made by the Casino Licensee to the community that the casino is a vital part of.
