Record iGaming Revenue Highlights PA Gaming Control Board's October Financial Report

HARRISBURG, PA: The Pennsylvania Gaming Control Board ("PGCB") reported today that the combined total revenue generated from all forms of gaming, along with fantasy contests, during October 2025 was \$596,970,584, an increase of 20.22% compared to revenue generated in October 2024.

The total revenue from gaming includes all those regulated by the PGCB: retail slot machines and table games; casino-type games offered online ("iGaming"); sports wagering (both retail and online); fantasy contests; and video gaming terminals ("VGTs"). The PGCB has posted separate reports for these types of gaming on its website, https://gamingcontrolboard.pa.gov.

Highlighting the report was a record amount for revenue generated through iGaming. That figure reached \$251,097,586 in October, eclipsing the previous high set in March 2025 of \$238,220,161.

Total tax revenue generated collectively through all forms of gaming and fantasy contests was \$252,287,937* during October 2025.

The following chart compiles all revenue generated in October 2025 by casinos, along with fantasy contests and VGTs operated by other vendors and includes a comparison to total revenue generated in October 2024.

Retail Slot Machine Revenue

This October's revenue from the play of retail slot machines was \$203,502,109, a 1.43% increase in revenue when compared to the \$200,625,182 generated in October 2024.

The number of slot machines in operation in October 2025 was 24,299 compared to 24,485 at the casinos in October 2024.

Retail Table Games Revenue

Retail Table games revenue for October 2025 was \$76,098,010, an increase of 2.97% from October 2024 when revenue was \$73,900,826.

Internet Casino-Type Gaming (iGaming) Revenue

Casino games offered online generated monthly revenue totaling \$251,097,586 during October 2025 compared to \$189,027,924 in October 2024, an increase of 32.84%. Within that number, revenue for both online slot machine and table games reached monthly highs.

Sports Wagering Revenue

October 2025, total sports wagering handle was \$968,507,712, or 12.86% higher than October 2024 total of \$858,148,994. The October 2025 wagering handle was an all-time high eclipsing the \$935,530,170 wagered in November 2024.

At the same time, the taxable revenue figure for October 2025 was \$60,674,209 or 121.66% over October 2024 when taxable revenue was \$27,373,043.

Tax revenue generated from sports wagering during October 2025 was \$21,842,715*.

Video Gaming Terminals

Total adjusted revenue for October 2025 for video gaming terminals (VGTs) was \$3,520,324, or 1.02% lower than October 2024 when revenue was \$3,556,562. By the end of October 2025, all VGT Operators offered the maximum permitted five machines at 76 qualified truck stop establishments, compared to five machines at 74 establishments at this time last year.

About the Pennsylvania Gaming Control Board

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of gambling involving 17 land-based casinos, online casino games, retail and online sports wagering, and Video Gaming Terminals (VGTs) at qualified truck stops, along with the regulation of online fantasy sports contests.

The land-based casino industry in Pennsylvania consists of six racetrack (Category 1) casinos, five stand-alone (Category 2) casinos, two resort (Category 3) casinos and four mini-casinos (Category 4). A significant job generator in the Commonwealth, casinos and the other types of Board-regulated gaming generated \$2.8 billion in tax revenue in Fiscal Year 2024/25.
