




#### **Slot Mix Count**


- Opening with 600 slot machines with capacity to grow to 750 slot machines (based on real data from customer preferences and trends)
- Target delivery date of slot machines is December 15, 2025 (pending license issuance)

#### Slot Mix Strategy and Rationale

- Balanced mix of proven, high-performing themes across Aristocrat, Light & Wonder, IGT, Konami, AGS, Ainsworth, and Aruze
  - o Selections *guided by market research* on player demand, competitor mix, and regional performance trends
  - o Focus on popular and classic titles with *strong performance history in Pennsylvania*
  - Game library selected based on volatility, hit frequency, and entertainment value to support broad guest appeal
  - o Inclusion of leased premium products to ensure *variety, freshness, and top-tier progressive* brands
  - Strategic placement of video poker, low denomination, and mid denomination core games to satisfy casual and recurring local play
  - o All games and configurations aligned with PGCB regulations, approved software, and certified device standards
  - Designed to deliver an engaging, modern floor that supports revenue, player satisfaction, and regulatory compliance

#### Table Games Mix Strategy and Rationale

- Thoughtfully designed to *support newer dealers and supervisors* who are transitioning into their roles
- Goal of this approach is to create an environment that fosters
  confidence and skill development by intentionally limiting the inclusion
  of games that typically require more advanced dealing experience
- Mix aligns with preferences of a market that is new to table games by offering a welcoming and non-intimidating experience for players
- Target delivery date of Table Games is February 15, 2025
- Plan to gradually consider additional games that have been successful with competitors, including:
  - Criss Cross (Novelty Poker)
  - Panda Bet (Baccarat variation)
  - High Card Flush (Novelty Poker)
  - Blazing 7s (Progressive Bet Option)

## Happy Valley Casino Dealer School

- Huge response with 250+ applications submitted
- 12-week commitment, 20 hours per week
- Classes begin December 15, 2025 and January 5, 2026
  - Flexible class availability
    - Weekdays: 4-hour classes (morning, afternoon, evening, & night)
    - Weekends: 10-hour classes
- *Paid training* \$15/hour
- Instructors onboarded starting November 10th
- Preparations:
  - Training tables and chairs arrived week of November 10
  - Training chips, cards, dice, and layouts received
  - Camera coverage, keys, locks, and cabinets are installed and operational





# Surveillance + Security

#### Surveillance Coverage

- HVC Standards for Slots Coverage
  - All slot game areas will be covered by PTZ (Pan, Tilt, Zoom) cameras to provide 100% coverage of each respective Slot Zone.
    - This coverage will allow for the reading of slot machine asset/location tags and jackpot verification.
  - The Surveillance System will also leverage strategically placed 360° cameras in all Slot Zones to provide additional Static coverage of their respective areas.
- HVC Standards for Table Games Coverage
  - o Each Table Game will be covered by at minimum, one dedicated "Fixed" overview camera with sufficient resolution to identify currency, playing card value, dice totals and cheque value.
    - Roulette tables will be covered by a minimum of two (2) "Fixed" cameras. One camera dedicated to the table layout and one camera dedicated to the wheel head.
    - Craps tables will be covered by a minimum of two (2) "Fixed" cameras. One camera to be focused on "2nd Base" (Left side of table) and one camera to be focused on "3rd Base" (Right side of table).

#### Surveillance Coverage

- Minimum Staffing Levels to Provide Adequate Coverage
  - HVC has developed and is in the process of submitting a Minimum Staffing Plan designed to provide 24/7 coverage of all Slot areas, Table Games areas, Cage Operations and Count Room Operations.
    - A minimum of three (3) Surveillance Operations employees will be on property at all times.
    - A minimum of one (1) Gaming level 2 licensed employee will be on staff in Surveillance Operations at all times.
    - A minimum of two (2) Surveillance Operations employees will staff the Monitor Room at all times.



### Security Coverage/Ops Rules

- HVC Standards for providing Security to Slot Operations
  - Slot Drops
    - HVC Security has implemented the following procedures to protect personnel and currency in the following manner
      - Security shall utilize a dual locked cart for secure transport of Hot boxes removed from the Slot Machines and transported to the Cage.
      - Prior to entering and servicing the Zone to be dropped, Security Officers will clear the Zone of any employees or unauthorized personnel.
      - Security shall constantly monitor Zone during the Drop to ensure no employees or unauthorized personnel enter the Zone.
      - Designated Slot Drop Routes have been developed to ensure safety of all currency transports from slot zones being dropped to the Cage.
  - Emergency Drops
    - Security Officers will secure the area directly to each side of the Slot Machine utilizing Officer accompanying Cage employee and the Officer assigned to the Zone containing the slot.
    - Return to the Cage utilizing the most direct route scanning for any threat or interference with the transport.

## Security Coverage/Ops Rules



- HVC Standards for providing Security to Table Games Operations
  - Employee & Guest Safety
    - Security will respond promptly to all requests for assistance from Table Games staff.
      - Using deescalation tactics and effective communication, all attempts to resolve any employee or guest safety issue will be taken to remedy a situation to a satisfactory conclusion.

#### Chip Fills / Credits

- Security Officers will securely transport the Chip Carrier directly to the appropriate table not deviating from the most direct route.
- Security will stand by and wait to place the Chip Carrier directly in front of the Dealer when directed to do so by the Table Games Supervisor.
- Remain at and ensure the integrity of the transfer by not leaving the table until required documentation is completed and the slips are dropped.
