**Definition:**

The iGaming Compliance Representative is responsible for monitoring, reviewing, verifying, and reporting on iGaming programs/applications, software, platforms, and system architecture to ensure compliance with law, rules, regulations, and internal controls enforced by PGCB. The representative reviews changes to iGaming applications and related platforms to evaluate, verify, validate or test approved interactive gaming equipment operations and functionality and coordinates corrective activities with interactive gaming industry managers to ensure the integrity of iGaming and to protect the public. Additionally, the representative receives and investigates patron complaints; prepares reports and communications of findings; conducts and aides patron initiated self-exclusions; and refers or recommends administrative, regulatory, or criminal actions to other bureaus or offices within the PGCB. The position reports to an iGaming Compliance Supervisor within the iGaming Unit of the Bureau of Gaming Operations.

**Minimum Experience, Education and Training:**

A Bachelor's degree;

Or four years of security or surveillance experience, of a technical level

Or an equivalent combination of experience and training.
