EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole, started his report by requesting that the Board ratify the purchase of certain business-related insurance policies, including the Board's Directors' and Officers' liability insurance, employment practices liability insurance, and the excess liability insurance policies.
