A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on December 17th to discuss personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters coming before the Board on December 18th.

Chair Smyler also announced December 2024 is the 20th Anniversary of the first meeting of the Pennsylvania Gaming Control Board. Executive Director, Kevin O'Toole, and previous Chairman, Thomas "Tad" Decker, provided brief remarks to recognize this milestone.

MINUTES/TRANSCRIPT

On a motion by Commissioner Manzano-Díaz, seconded by Commissioner Hickernell, the Board unanimously approved the minutes and transcripts of the September 18, 2024, meeting.

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole, began his Executive Director's report by requesting that the Board ratify the purchase of certain business-related insurance policies, including the Board's Directors' and Officers' liability insurance, employment practices liability insurance, and the excess liability insurance policies.

Kevin explained the purchase of the aforementioned policies is authorized by Section 1202 of the Pennsylvania Race Horse Development and Gaming Act and have been in place since 2006.

Mr. O'Toole further explained the Office of Chief Counsel, the Board's Procurement and Property Manager, along with the Department of General Services, and the Bureau of Risk and Insurance Department all worked together to secure the appropriate insurance policies. These policies went into effect, upon the termination of the prior policies, on December 5, 2024.

Kevin concluded his report by requesting a motion ratifying the Board's entry into the insurance purchase agreements.
