A quorum of the Board being present, Chair Smyler called the meeting to order.

ANNOUNCEMENTS

Chair Smyler announced that the Board held an Executive Session on March 24th to discuss personnel matters and to conduct quasi-judicial deliberations relating to matters coming before the Board on March 25th.

Chair Smyler also announced that a non-public hearing had been held regarding certain aspects of the BetMGM, LLC Consent Agreement on the agenda. The Office of Enforcement Counsel and BetMGM discussed some aspects of the Consent Agreement, which were appropriate for public consumption, and the underlying facts that led to it.

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Kevin O'Toole, began his report by stating that with Problem Gambling Awareness Month coming to a close, the Board has taken steps to bring awareness to problem gambling and how accessible it is to get help. He continued by stating that the Gaming Control Board ensures transparency and access to resources that raise awareness of problem gambling through a dedicated website that is maintained by Board staff. This website links citizens to critical information about the programs and resources available to them and can be found at www.responsibleplay.pa.gov. From the site, patrons can access the Pennsylvania Gaming Control Board's self-exclusion enrollment website for anyone seeking to be excluded from one or more forms of gaming regulated by the Board. Director O'Toole went on to say that the process is safe and secure; also adding that patrons have the option of reaching out to the Board's Office of Compulsive and Problem Gambling for assistance or for information on in-person enrollment options.

Executive Director O'Toole also discussed the "WhatsReallyatStake" campaign that will be utilizing social media, online advertising and access to promotional materials, such as posters, to promote the campaign. Materials are available as a free download at the WhatsReallyatStake website, whatsreallyatstake.com, under the "Resources" section.

Executive Director O'Toole ended his report by stating that while the goal of Problem Gambling Awareness Month is to increase public discussion around problem gambling and promoting prevention, treatment and recovery services, the Gaming Control Board's goal is to promote problem gambling and underage gambling throughout the year.
