Chair Smyler announced that the Board held an Executive Session on April 28th to discuss personnel matters and to conduct quasi-judicial deliberations relating to matters coming before the Board on April 29th.

MINUTES/TRANSCRIPT

On a motion by Commissioner Quiñones Sánchez, seconded by Commissioner Manzano-Díaz, the Board unanimously approved the minutes and transcripts of the February 4, 2026 meeting.

On a motion by Commissioner Manzano-Díaz, seconded by Commissioner Huffman, the Board unanimously approved the minutes and transcripts of the February 25, 2026 meeting.

EXECUTIVE DIRECTOR'S REPORT

Executive Director Kevin O'Toole provided an update on the opening of Happy Valley Casino in State College, Pennsylvania, the Commonwealth's 18th land-based casino and the first and final mini-casino authorized under the 2017 gaming expansion legislation.

The Bureau of Casino Compliance conducted two successful test nights on April 24 and 25, 2026, during which approximately 2,500 patrons attended each evening. The casino operated with 30 table games and approximately 600 slot machines, with a portion of proceeds benefiting local charities.

Following the successful testing period, Happy Valley Casino was authorized to officially begin operations on April 27, 2026.

Director O'Toole concluded this report by recognizing Gregg Hazzouri, Director of the Bureau of Casino Compliance, and his staff for their outstanding work in assisting the team at Happy Valley Casino to successfully reach their casino opening.

OFFICE OF FINANCIAL MANAGEMENT

Director of Budget David Rhen provided an update of expenditures through the end of the third quarter of Fiscal Year 2025-2026. Total Board expenditures were reported at \$42.8 million against an appropriation of \$60.4 million, with overall expenses remaining in line with expectations.

Director Rhen noted that the expenditure increased by approximately \$2.4 million compared to the same period in the previous fiscal year, primarily due to rising personnel costs. Payroll expenses totaled \$37.9 million, representing 89% of overall costs to date, including \$22.8 million for salaries and \$15.1 million for benefits. Benefits were reported as 66.7% of salary costs, and payroll expenses for the year increased by approximately \$2.2 million.

He ended his report by stating that operating expenses totaled \$4.9 million, an increase of approximately \$236,000 over the prior year. The largest operating expense categories were \$2.4 million (49%) for services (predominately for IT modernization and interagency billings for services provided by other state agencies to the Board. \$1.2 million for rentals and leases and \$872,000 for other operating expenses, including fingerprinting and database fees associated with background investigations.
