UNVEILING OF 20-YEAR SERVICE AWARDS PLAQUE

Executive Director Kevin O'Toole provided an update regarding the agency's new employee recognition tribute initiative. Following the Pennsylvania Gaming Control Board's (PGCB) 20th anniversary celebration, the agency held an employee design contest to create a tribute recognizing employees who achieve 20 years of service with the PGCB.
