RE: Roulette Lite Waiver Request

Dear Ms. Stronge:

On behalf of the Pennsylvania Gaming Control Board ("Board" or "PGCB"), I have reviewed your waiver request and subsequent correspondence on behalf of DraftKings, in which DraftKings is requesting a waiver of 58 Pa. Code § 617a (Roulette), to offer Roulette Lite, a roulette game with limited wager options.

DraftKings has represented that its Roulette Lite game's structure, although reducing the number of wager options compared to § 617a., follows the rules and procedures of Roulette and affords the same return to player as Roulette offered on a double zero wheel. DraftKings has informed PGCB that its Roulette Lite game has been granted approval, and has gone live in New Jersey, Connecticut, Michigan, West Virginia and Ontario.

DraftKings, is seeking a waiver of 58 Pa. Code § 617a., to limit wagers options, and associated payout odds, as follows:

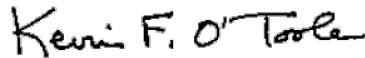
Wager	Payout
Dozen (1 st , 2 nd , or 3 rd twelve)	2 to 1
Odd	1 to 1
Even	1 to 1
Low (1-18)	1 to 1
High (19-36)	1 to 1
Red	1 to 1
Black	1 to 1
0/00	17 to 1
0/00/1/2/3 (Basket Bet/ Top Line)	6 to 1

Upon review, the wagers and payouts proposed line up with the wagers and payouts under §§ 617a.3 (relating to placement of wagers) and 617a.4 (relating to payout odds), with 0/00 representing the sole split wager to be offered.

At this time, I grant DraftKings' waiver request for its Roulette Lite game with the wagers and associated payout odds as outlined above. All aspects other than the wagers and payouts provided under this waiver shall follow the rules and procedures for Roulette provided under 58 Pa. Code § 617a. Additionally, Roulette Lite shall not be permitted to go live in Pennsylvania until the game and any associated systems has undergone the PGCB review processes.

The waiver issued pursuant to this letter shall expire at such time that regulations are adopted by the Board and published in the *Pennsylvania Bulletin*. If you have any questions, please contact Robert Wood, Assistant Chief Counsel, via email at [REDACTED].
