RE: "No Spin" Message in Live Dealer Roulette Waiver

Dear Ms. Meyer:

On behalf of the Pennsylvania Gaming Control Board ("Board"), I have reviewed your email correspondence of April 27, 2022, regarding Evolution's Live Dealer Roulette game. Specifically, you request a waiver of Board regulation 617a.6(b), which requires a dealer to announce "no spin" if the ball fails to complete four revolutions around the wheel. Evolution's proposed modification to this requirement would be a message displayed to patrons playing the Live Dealer Roulette game, versus a verbal announcement by the dealer of the issue causing the "no spin" to occur.

At this time, I approve the implementation of the requested waiver, permitting Evolution to enable the "no spin" module button on this game. All other aspects of the Live Dealer Roulette game must be offered in accordance with the provisions of Chapter 617a, unless additional regulatory waivers are or have been requested and granted.
