RE: Fantasy Contest Operators Submission of Participant Complaints

Dear Mr. Krombolz:

As required by 4 Pa.C.S. § 325 (4.3), fantasy contest operators licensed in the Commonwealth of Pennsylvania are required to provide to the Pennsylvania Gaming Control Board ("Board") copies of each participant complaint received on a quarterly basis. The purpose of this letter is to provide guidelines and information about the Board's expectations to ensure compliance with this statutory provision.

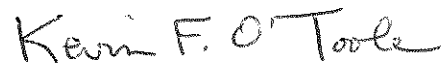
Please be advised that complaints submitted by Pennsylvania residents must be provided to the Board by the 15th of the month following the end of each calendar quarter (Eg. April 15, July 15, October 15 and January 15). Complaints can be summarized and provided in spreadsheet format to include:

- Date received
- Internal ticket number (if applicable)
- User ID and user name
- First and last name
- Address (city and state is acceptable)
- Description of the complaint or issue type
- Status
- Resolution date
- Resolution description

For the quarter ending September 30, 2019, it is acceptable to submit patron complaints by November 15, 2019. All complaints must be submitted to the Board via e-mail to: RA-gamingops@pa.gov with the words "Fantasy Complaints" as first part of the e-mail subject line, followed by the name of the licensee and the quarter/year (Eg. Fantasy Complaints-ABC Fantasy LLC-Q3/2019).
