RE: Galaxy Gaming's Rising Phoenix, Golden Talons, and Harmony Progressive Waiver Request

Dear Ms. Cox:

On behalf of the Pennsylvania Gaming Control Board ("Board"), I have reviewed your May 25, 2023, correspondence regarding Galaxy Gaming's regulatory waiver request, concerning Rising Phoenix Baccarat, Golden Talons, and Harmony Progressive Baccarat side wagers and variations. Galaxy Gaming is seeking permission to implement these side wagers and variations on Mini-baccarat and Midi-baccarat offerings, consistent with the regulations for these items, 58 Pa. Code §§ 631b.8 – 651b.10 (Baccarat side wagers and variations).

At this time, I approve the implementation of the requested waiver, permitting Galaxy Gaming to offer Rising Phoenix Baccarat (58 Pa. Code § 631b.8), Golden Talons (58 Pa. Code § 631b.9), and Harmony Progressive (58 Pa. Code § 631b.10) on Mini-baccarat (58 Pa. Code § 627a) and Midi-baccarat (58 Pa. Code § 629a) game offerings.

At such time that Temporary Regulations incorporating Rising Phoenix Baccarat, Golden Talons, and Harmony Progressive into Mini-baccarat and Midi-baccarat are adopted by the Board and published in the *Pennsylvania Bulletin*, this waiver shall become null and void.
