Dear Ms. Palmateer:

On behalf of the Pennsylvania Gaming Control Board ("Board"), I have reviewed your May 10, 2024, correspondence regarding Chester Downs and Marina, LLC's ("Harrah's") regulatory waiver request regarding the 5 Treasures side wagers. Harrah's seeks permission to implement the 5 Treasures side wagers on Minibaccarat and/or Midibaccarat offerings, consistent with the 5 Treasure Baccarat wagers regulation 58 Pa. Code § 631b.3.

At this time, I approve the implementation of the requested waiver, permitting the 5 Treasures Baccarat wagers (58 Pa. Code § 631b.3) to be offered on Minibaccarat (58 Pa. Code § 627a) and Midibaccarat (58 Pa. Code § 629a) game offerings. At such time that Regulations incorporating 5 Treasures wagers into Minibaccarat and Midibaccarat are adopted by the Board and published in the *Pennsylvania Bulletin*, this waiver shall become null and void.
