RE: Playtech - Spin A Win

Dear Mr. Walensky:

On behalf of the Pennsylvania Gaming Control Board ("Board" or "PGCB"), I have reviewed your waiver request and subsequent correspondence on behalf of Playtech, regarding its Spin A Win game. Playtech had previously been granted a waiver relating to its Spin A Win game on January 12, 2023. The present Playtech Spin A Win waiver request seeks to expand upon the January 12, 2023, waiver and to include certain side wager configuration options.

The present Spin A Win waiver request recognizes that the base Spin A Win game aligns with 58 Pa. Code § 689a. Dreamcatcher and seeks allowances for optional side wagers. Specifically, Playtech seeks permission for the following optional side wagers and associated payouts:

Wager	Payout Odds
Odd	3 to 4
Even	5 to 4
Any Multiplier Wedge	25 to 1
Multiplier x2 Wedge	51 to 1
Multiplier x7 Wedge	51 to 1
Any Multiplier Wedge with an odd number on the next spin	44 to 1
Any Multiplier Wedge with an even number on the next spin	59 to 1

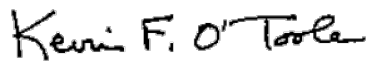
At this time, I grant Playtech's waiver request for its Spin A Win side wagers subject to the following:

1. The base Spin A Win game, shall operate pursuant to the rules and procedures as outlined under §689a. Dreamcatcher unless otherwise provided by the Board; and

2. Spin A Win may offer the optional side wagers with the payout odds noted above, subject to:
 - a. The optional side wagers are offered on base games offered under the rules and procedures of 58 Pa. Code §689a. Dreamcatcher.
 - b. A player must place a base game wager to be eligible to place an optional side wager.
 - c. Optional side wagers may not exceed 2 times the player's base game wager.

The waiver issued pursuant to this letter shall expire at such time that regulations are adopted by the Board and published in the *Pennsylvania Bulletin*. Additionally, this waiver shall supersede and nullify the January 12, 2023, Spin A Win waiver issued to Playtech.
