RE: LNW Gaming, Inc.'s Dice-Ology

Dear Mr. Casole,

On behalf of the Pennsylvania Gaming Control Board ("Board" or "PGCB"), I have reviewed your correspondence and gaming lab submission, regarding LNW Gaming, Inc.'s Dice-Ology product. Odds On Compliance, on behalf of LNW Gaming Inc., made a table game submission, requesting Dice-Ology be approved as a side wager for the game of Craps, and that regulations be promulgated for Dice-Ology.

Upon review, Dice-Ology, which is comprised of three wagers (Little Ones, Big Ones, and Boom or Bust) and two potential paytables, operates consistently with the Bonus Craps wager authorized under 58 Pa. Code § 623a.3(a)(43) and Bonus Craps alternative payable options under 58 Pa. Code § 623b.3. Based upon the information you have provided, Dice-Ology's Little Ones wager functions as the Bonus Craps All Small Wager (see 58 Pa. Code § 623a.3(a)(43)(i)). Dice-Ology's Big Ones wager functions as the Bonus Craps All Tall Wager (see 58 Pa. Code § 623a.3(a)(43)(iii)). Dice-Ology's Boom or Bust wager functions as the Bonus Craps All or Nothing wager (see 58 Pa. Code § 623a.3(a)(43)(iii)) also known as the Make'em All (see 58 Pa. Code § 623b.3). Finally, the two paytables LNW has proposed for Dice-Ology match the payout odds provided by payable 1 and payable 2 under § 623b.3(c).

Based upon the information you have submitted, Dice-Ology and its associated wagers are the Bonus Craps wagers authorized pursuant to 58 Pa. Code §§ 623a.3(a)(43) and 623b.3. Therefore, no additional regulations need be promulgated.
